





vents are way of life in modern society. They are form of expressions, whether it is private celebrations, political rallies, public grief, sports tournaments, musical concerts or even fund raising gathering, events mirror the society. It's a show of strength and solidarity. In modern society organised events are used for multiple purposes and the basic criteria for all the successful events is a proper management.

Nepali community is the fastest growing field for event managers. Rapidly growing Nepali population has led to the proliferation of large number of event management firms and individuals that are appraising their future prospect into it.

In Victoria alone there are over half a dozen event management companies that are active. Most are commercial firms and their motive behind organising events is effectively to make bucks and there are few that also want to use their events to give back to community. Since these are the com-

munity based activities, it poses a topic of discussion for the community as to how profound and impactful these events are being for us.

As it stands:

Only till half a decade ago Nepali events in Victoria were rare occurrences. Apart from family and festival gatherings, there weren't many public events happening as such. Few years on, the scenario has changed dramatically. Commercial event management companies, community organisations such as NRN and NAV and sports clubs-they all use events to meet their aspirations. We now see pubic events being held almost every second day. It is a natural progression for events and activities to occur as by-products of growing Nepali population but the disproportional supply versus demand can also have negative effects to all stakeholders.

There are few established event management firms but there are some new ones that lack what's required to put up a successful event.

Challenges

Non Residential Nepalese Association, Nepalese Association of Victoria and other community organise various activities as part of their event calendars. NAV's Dashain festival, Teej Mela, Childrens's Day are increasingly popular. These events play an important role in preservation of our traditional culture. What NAV does with its festivals is an extraordinary example of community harmony. Highly participated and thoroughly embraced. For instance, Teej Mela, a yearly NAV event is probably the biggest of Nepali women gathering not only in Australia but in the whole Nepalese Diaspora. Such events are a pride of the community.

Events have become a means for businesses to promote their products and services. As they could get their message straight to the target market, many Nepalese businesses are hosting community events or sponsoring them. Migration agents, educational institutes and colleges, travel agencies, restaurants they all seem to be on board. So its suffice to say that events have provided a great platform to link businesses to its primary customers directly. In that sense, it's a win-win for businesses, event management companies and the general community members. Business get to reach out to their potential clients, organisers get sponsored and the community get to know about more service providers to choose from.

Events have also become a way of recreation for the community, specially for youths that would otherwise work around the clock, to just chill and enjoy some times with mates.

Most event management companies rely on the sponsorship from businesses and the ticket sale. As there are limited number of Nepali businesses, there is only so much they can offer. Leave a couple, there aren't too many businesses that can allocate significant marketing budget. So event managers are left with no options but to turn to same businesses again and again for sponsorships. "Too many, too soon" has also affected the revenue from ticket sale. So the shrinking budgets have directly effect on the quality of the event.

There are few established event management firms but there are some new ones that lack what's required to put up a successful event. The recent trend also suggest that many new organisers do these events just for the glamour of it rather than with a long term vision. This has resulted in many unsuccessful events, an embarrassment for the organiser, performers and the participants.

In conclusion, events should have some sort of positive impact on community. After, having spent so much in organising it, there should be some sort of an effect that could better us as community. If we intend to just gather and party, by all means, it's an individual right. But if we are promoting, publicising and selling it as a public eventwe need to be careful.



Director of Consumer Affairs Victona Dr Claire Noone says that increased competition and the growth of online bookings has changed the way people plan and purchase their trips. "For some people, booking a holiday might be a quick and simple process, while others put a lot of time and effort into planning their trips."

"We know that Australians love travelling, and many go back to their countries of origan to visit family and friends," says Dr. Noone.

Statistics show that Australians made nine million trips overseas in the past year. "It is easy to get too excited about a holiday and forget about the simple precautions you should be taking to protect your purchase."

Dr Noone says that apart from protections that all consumers have under the Australian Consumer Law, there are some basic steps they can take to protect their purchases

"Reputation and customer service is a really simple way of making sure that your holiday is going to be a great one," says Dr Noone

"Look at reviews and ask family, friends and others in your community for their recommendations. If you are booking with a travel agent, check that they are accredited. Any business you book with, either in person or online, should have clearly stated refund and complaint policies."

Consumers can also protect themselves by choosing how they pay for their travel

"Credit cards can be a more expensive way to pay for purchases but do offer some protection as consumers may be able to seek a reverse payment from their bank if they book and do not get what they paid for."

Consumers can ask their bank to reverse a payment if it was made with credit cards or by selecting 'credit' on Mastercard or Visa debit cards, not

if they paid by 'cheque' or 'savings' on debit cards, cash, cheque, money transfer, direct debit or BPAY

Holidaymakers are strongly encouraged to take out comprehensive travel insurance when they are travelling, and check what circumstances and activities are not covered by their policies.

Nepal sets world's largest **HUMAN FLAG RECORD**

ore than 35,000 Nepalese made a bid last month to form the world's largest "human national flag" as they sought to set a new international record. As the country's anthem played, participants held up crimson, blue and white coloured cardboard for 10 minutes on an open ground in Kathmandu's city centre to form the national flag

Cries of "Nepal!" rang out as participants threw the cardboard pieces in the air to celebrate after the attempt. Nepal's flag is the world's only one which is not a quadrilateral. Instead it is comprised of

"We conceived this idea to spread the message that all our countrymen are united under one flag," said Bhawesh Khanal, president of Human Values for Peace and Prosperity, the group that spearheaded the event.

Nepal is in the process of drafting a new constitution, a key step in a stalled

peace process begun after the end of a ten-year civil war in 2006. Leaders have promised an inclusive constitution and . federalism, ending gender and castebased discrimination.


Numbered tickets were handed out to participants to keep a count of how many took part in the flag event. "Our vision came true. Thousands of people came together to form our country's flag and claim a new world record," Khanal told the media. He said the group will

now submit its claim with photographic and video evidence for a new record to the headquarters of Guinness World Records in London. They expect Guinness World Records to give a ruling on their submission within two months.

The current record for the world's largest human national flag was set in February 2014 when 28,957 people gathered in Lahore, Pakistan, to create a Pakistani flag, according to Guinness World Records.

NRNA Australia signs MoU with FORWARD Nepal and IPNI for skills and knowledge transfer in eastern Nepal

MoU for an agriculture-focused project entitled, "Transfer, evaluation and dissemination of an innovative fertilizer management tool (Nutrient Expert) for increasing crop yields and farmers' income" was signed by the representatives of NRNA Australia, FORWARD Nepal (a Chitwan-based NGO) and International Plant Nutrition Institute (IPNI), South Asia Office, New Delhi on 16 August in Birtamod, Jhapa. Dr. Jagadish Timsina (Advisor, NRNA Australia and Member, NRNA ICC/NCC Committee), Mr Netra P Sen (Executive Director. FORWARD Nepal) and Dr. Kaushik Majumdar (Director, IPNI, South Asia) signed the MoU during their 2-days hectic programme of farmers' field visits and interactions with several groups of farmers in Jhapa and Morang districts on 15 and 16 August. The project proposal was presented by the project leader Dr. Jagadish Timsina during the NRNA Australia's "Skills, knowledge and innovation (SKI) transfer" workshop on 19 July in Sydney. This project will be implemented from the upcoming winter season with support from IPNI, initially for 2 years, and will be the NRNA Australia's first project under the "SKI transfer" theme to be implemented on the ground. The project will focus on improving nutrient and fertilizer management practices for rice, maize and wheat crops to increase crop yields and farmers' income. FOR-WARD Nepal will be the implementing organization and NRNA Australia will provide the skills and knowledge necessary for the project. The project will

initially conduct nutrient management evaluation trials with active participation by farmers and local stakeholders. It will initially work with 200 farmers in the two districts in the first year and will upscale upto 5000 farmers by three years. It is expected that after three years project staff and stakeholders and farmers will learn about scientific method of nutrient management practices for the above three crops and farmers' income will increase substantially through increases in crop yields.

The objectives of this visit by the joint team was (1) to sign the MoU (2) to conduct the rapid rural appraisal of the project command areas, (3) to select project villages, and (4) to understand the farmers' existing cropping systems, and nutrient/fertilizer management practices for above three crops so that economically-optimal nutrient/fertilizer management recommendations could be made for each participating farmer's field considering each farmer's man-





agement practices in each field. During the 2-days visit, four FORWARD staff, two IPNI staff and Dr. Timsina traveled together and interacted with two farmers' groups in Babia Birta and Itahara villages in Morang district and two groups in Dhukurpani and Gauradaha villages in Jhapa district. At least 20-40 farmers comprising of both males and females participated enthusiastically in each village. Farmers were extremely cooperative, enthusiastic, and were keen and interested to share their knowledge and experience on farming to the project team members and showed their full commitment and support to participate in the project. Farmers from nearby villages also rushed to the interaction sites and requested the team members to hold such meetings to their villages too.

FORWARD Nepal and NRNA Australia will organize the project inception workshop on 6th October in Chandragadi, Jhapa where local stakeholders and representatives from different agriculture organizations and NGOs will be invited. Farmers' field visits and interactions with more groups of farmers in other villages will also be orgnised on the 7th October where Dr. Timsina will represent from NRNA Australia and will lead the team.

During his visit to eastern Nepal, Dr. Timsina also visited the NRNA Australia's Bridhashram (Sradhashram) project site in Biratnagar together with the member secretary of the Bridhashram project and staff of Biratnagar Municipality Mr Punam Dahal and obtained up-to-date information about the project.

Huge marble statue of Lord Shiva unveiled in Campbelltown, Sydney



he Mukti-Gupteshwar Mandir Society has unveiled a large statue of Lord Shiva. The height of the Statue, including the pedestal, is approximately, 4.5m. The statue is carved from one piece white marble and weighs 3.5 tonnes. A special crane was used to lift the statue onto a specially constructed concrete pedestal.

The statue of Lord Shiva has four arms, rear two arms carrying a trident and a small drum. Shiva is wearing a snake and prayer beads all carved from the same piece of marble.

This form of Lord Shiva is known as the provider of salvation and freedom from cycle of birth and rebirth to devotees. The statue is fitted with seven coloured LED lights and is striking at night, with colours changing every minute over the seven colours for a seven minute cycle.

A ceremony has been conducted which is Hindu term has brought the sacred image to life. There are two ways to understand the ceremony. The first is as a contract between the Deity and devotees. The Deity agrees to descend into the sacred image, and the devotee agrees to care for the Deity in the form of service to the community. The ceremony causes the Deity to awaken within the stone. The other view is more theological. By definition, God is all pervading and omnipresent and so breath does not need to be established within the statue because God is already there! On this view, the purpose of the ceremony is to awaken the minds of devotees to the presence of divinity within the sacred image. At the start of the ceremony people see only stone but by the end they see God. The real installation takes place not on the stone but in the minds of the participants.

Lord Shiva is an exciting newcomer to the attractions of the Campbelltown-Macarthur region, and a great example of cultural enrichment brought by Australians of the Hindu faith





Pathways to Australian **Permanent Residence for** International Students

any international students studying in Australia hold the dream of being able to remain within Australia permanently in order to establish a home and family after the expiry of their student visas. This dream can become a possibility if a graduating student fulfils the eligibility criteria for particular visas which can provide a pathway to obtaining permanent residency upon completion of their studies. In all cases health and character requirements will apply, though they may vary in particulars for each sub-class.

As with any summary of such complex matters, the devil is in the details so professional advice from an experiences Australian registered migration agent (who is preferably a lawyer also) is crucial to avoid mistakes*. Even the tiniest mistake can render an application unsuccessful. The "pathway" visas

Skilled Recognised Graduate subclass 476 visa

Applicable to recent graduates younger than 31 years of age who have completed an eligible engineering qualification from a recognised institution in the past two years. Applicants can not have held a Skilled - Recognised Graduate visa (subclass 476) or a Temporary Graduate (subclass 485) before (unless they were a dependent family member) and be able to demonstrate English language ability.

An applicant may apply for this visa from both inside or outside of Australia however an applicant must be outside of Australia when the application is decided. This visa allows holders to travel, work, enrol in further educational studies and additionally study in order to improve their English skills. Holders of this visa may can be eligible to apply for permanent residence if able to meet the required pass mark for the General Skilled Migration points test. The visa is valid for up to 18 months.

Skilled Independent subclass 189 visa

Applicable if recently graduated from an Australian University whilst on a student or qualifying visa and in possession of a skilled occupation listed on the relevant Skilled Occupation list



and you have obtained a suitable skills assessment for that occupation and not yet turned 50 years of age and achieved the score specified in your letter of invitation based on the factors in the points

You must have at least competent English. In comparison to the skilled nominated subclass 189 visa however this visa does not require an applicant to be sponsored by an employer, family member or state government but can be applied for on an independent basis. The difficulties with this pathway will include being able to pass a skills assessment or obtain enough points if you have little work experience, as well as the inability to obtain a bridging visa until an actual visa application is made.

Skilled Regional subclass 489

This visa allows skilled workers to live and work in specified regional areas in Australia for up to four years. There are two streams for this particular visa:

1. Invited Pathway

Invited pathway which requires a

letter of invitation and nomination by either an Australian State agency or an eligible relative living in an area designated for the purposes of this visa.

You Submit an Expression of Interest and then might be eligible to apply for this visa if invited. When you are sent your letter of invitation, you must also have:

- **≯** been nominated by an Australian State or Territory government agency or sponsored by an eligible relative living in a designated area
- nominated an occupation that is on the relevant skilled occupations list
- a suitable skills assessment for that occupation
- not yet turned 50 years of age
- achieved the score specified in your letter of invitation based on the factors in the points test
- 7 at least competent English

2. Extended Stay Pathway

You can also apply for the Skilled Regional (Provisional) Renewal (subclass 489) visa if you hold a provisional visa in subclass 496, 495, 487 or 475

Extended stay pathway which requires an applicant to have held a provisional visa in subclass 475, 487, 495 or 496 for at least two years and want to extend your stay in Australia or be are a family member of someone who holds this visa (subclass 489) or a provisional visa in subclass 475, 487, 495 or 496. Apply for a Skilled Regional (Provisional) Subsequent Entrant (subclass 489) visa

It should be noted however that meeting the minimum requirements and criteria will not guarantee nomination by the state as the state will only select these applicants with the greatest chance of finding stable employment.

Skilled Nominated subclass

Applicable for recent graduates on a student or qualifying visa and in possession of an occupation listed on the State nomination list for graduates. This particular visa is points tested on a skill basis and in order to apply you must submit an expression of interest and then be invited through SkillSelect to lodge an application.

This particular visa is intended to

satisfy the high demand within Australia's labour market for potential employees possessing a particular skillset and as such possesses stringent minimum eligibility requirements. These include requirements similar to the subclass 489 visa however in addition PhD graduates who have completed a doctorate from an Australian educational institution or other doctorate of an equivalent nature in a specialist field listed on the State Nomination Occupation List may also be eligible for state nomination. Evidence proving successful completion of the PhD must be provided and the PhD must have been completed within the past 5 years.

Skilled graduate subclass 485 visa

Although this visa does not confer permanent residency it does allow a recent graduate from an Australian education to remain within Australia temporarily upon completion of studies for up to 18 months or more. There are two streams of Graduate Temporary Visa, these streams being:

- 1. Graduate work: An 18 month visa which requires applicants to pass a skills assessment in an occupation listed on the Skilled occupation list.
- 2. Post study work: A visa lasting between 2 years for these completing a Bachelor degree to 4 years for these completing a Doctorate. This particular stream does not require a skills assessment however there are relevant dates going back several years which must be investigated carefully in each case to ensure eligibility

This visa does not require nomination by a State agency in order for an applicant to apply.

Visas are also available for full-time work sponsorship on a permanent or temporary 4 year basis, usually with an Australian employer.

Other pathways may exist based on your financial and family situation in Australia. Professional advice must be sought at earliest as long term planning is required in this complex and ever changing field.

CALD Youth Census Report unveiled

CALD youth value education but need help finding jobs

new report into the culturally and linguistically diverse (CALD) and refugee youth in Australia says there's a need for a continuing focus on English, education and training, and employment. The Multicultural Youth Advocacy Network commissioned Professor Graeme Hugo to prepare the report, which contributes

to baseline knowledge about CALD and refugee youth in Australia.

The report has highlighted that It is important for policymakers at the Federal, State and Local area levels to understand the changing size and composition of its population. This report has focused on youth born in CALD and refugee countries between the ages of 12-24 and made comparisons with youth born in Australia at the state level to identify trends. It also point out that a great diversity of ethnicities within CALD and refugee population groups which not only requires a range of differing need and services but also translates into different settlement and distribution patterns that need to be understood more fully.

"However, it is useful to first assess them more broadly as population groups in order to understand how youth from CALD and refugee countries as new additions to the Australia's population are benchmarked against the Australian born youth population," the report said.

When it comes to education, the report said, it was encouraging to see that youth born in CALD and refugee countries and with CALD and refugee ancestry generally had comparable rates of being enrolled at an educational institution.

In fact, youth born in CALD countries and youth with CALD and refugee ancestry performed slightly better than their Australian counterparts in the 12-17 age. Overall, youth born in CALD and refugee countries and with CALD and refugee ancestry had higher participation rates as students in either a full or parttime capacity at an educational institution when compared to youth born in Australian.

While it is considered that the population of youth born in CALD countries partly comprises international students, there is also some evidence that there is a stronger emphasis placed on education for migrant youth. The inverse relationship between employment and education tion groups begin to converge towards the Australia born average. The Federal Parliamentary Secretary to the Minister for Social Services, Senator Concetta Fierravanti-Wells, launched The CALD Youth Census Report.

> The prosecution was the result of an investigation by the Department of Immigration and Border Protection (DIBP) into unlawful migration assistance to visa applicants. She was found guilty of providing false documentation to visa applicants in return for money. She was

sentenced to a community corrections order of 300 hours' community service over 18 months across all charges, fined \$10 000 and ordered to pay \$113.90 costs and \$4075 in repatriation orders.

These are two great and recent examples of how worrying the situation has been for International Students in Australia. As they require to seek assistance from the migration agents for their enrolment, course transfer, visa extensions and other services, Nepalese students are alarmed with the recent news about dodgy migration agents.

Suman Deuja from Nepalese Students Association of Victoria said, "So many of these victims could be our folks." He said "please be careful when you choose your migration agent. Their wrongdoing can ruin your career and waste your hard earned money." He said, "these recent incidents are quite worrying for international students specially for our folks whose fate relies on these agents." "I suggest everyone to do proper research before getting involved", he

guides, resources and a community implementation plan, with support from the Foundation.

Expressions of interest are invited from agencies with a strong history of working with CALD communities and the ongoing infrastructure to support sustainability of the work beyond the life of the project.

Minister for Community Services Mary Wooldridge said expressions of interest are now open and encourages agencies to submit their innovative approaches to delivering a prevention program specific to the needs of a CALD community.

"There are many inhibitors to speaking up about violence in culturally diverse communities - we are seeking to empower community members to speak out," Ms Wooldridge said. "The state Government has invested \$550,000 in the development of these family violence prevention programs that are specifically tailored to the needs of CALD communities."

Ms Wooldridge said the project will develop two separate family violence



Need to grow out of a timid psyche

Our Identity:

Nepalese community in Australia is rapidly growing but it is still considered relatively new to the broader Australian Community. Apart from being seen as the fastest growing community, the mainstream society would mostly identify with Nepalese as mountain climbing Sherpas that help their fellow climbers from the more affluent countries. Some would know Nepal as the birthplace of Lord Buddha, and some would harbour their sweet memories from 60s and 70s of walking side by side with cows on the streets of Kathmandu and purchasing hashish in a shop. For many Australians ,whose relatives fought in the World War II, Nepal represents home to the valiant Gurkhas. All in all, whichever way Australians find their individual connection with Nepal, it would not be an overstatement for me to say that Nepalese stand for simple, loyal, laid back, hardworking and harmonious community.

Our Position in Australia:

The Australian Bureau of Statistics shows a growing number of Nepalese in Australia has reached the vicinity of 25000. The unofficial figure as claimed by some community leaders, which includes students and temporary residents, takes it to over 50000 in NSW alone, and Melbourne being home of more than 10000 residents with their origin in Nepal. Despite this big disparity in the official and unofficial figure, there is no doubt that Nepalese community has grown by manifolds in the last decade.

When we migrate to any new country permanently, there is a need of integration and also expectation of the broader community that we try to assimilate. In essence, this is what naturalization means anyways. Within this context, it becomes relevant to talk about the community organisations that are set out to work towards the welfare of our community and help its members have smooth transitions between countries and the cultures.

Governing bodies:

Particularly in reference to our community in Victoria, there are two main Nepalese organizations that claims to be the top community bodies .First one is Nepalese Association of Victoria (NAV). Anyone with roots in Nepal is eligible for membership of NAV. The aim of this organization is to provide advocacy and practical supports to Nepalese in Victoria. NAV also organizes different festivals and celebrations, e.g. Childrens day as well as womens

day. There is another organization -Non-Resident Nepalese Association (NRNA-SCC) - State Coordinating Committee, which is a Victorian Chapter of a much larger network of Nepalese community worldwide. This organization is actively involved in lobbying and negotiating with the Government of Nepal, primarily for dual citizenship, in return of collective and individual investment from its members to Nepal. This organization also provides financial support to social work, mainly in Nepal and

also to the Nepalese communities in the countries where they are based. Both organizations aim to promote business and tourism in Nepal. The NAV is purely a Victorian organization governed and dictated by its constitution, where as the NRNA-SCC, being a part of a bigger organization has different executive layers and lacks independence that the NAV enjoys.

Although these two organizations appear to clash when it comes about taking leadership of the Nepalese communities in Victoria, so far their role in regards to the needy in the community has been appreciable. A significant proportion of people of Nepalese origin are affiliated with one or both of the above organizations.

Interestingly there are many other associations who follow political ideologies of most of the major political parties of Nepal . They have been established either as overseas branch of those political parties or identify themselves as affiliates of those political parties. More interestingly, some of the executives of such organizations are people of Nepalese origin who have acquired Australian

citizenship, and at this point in time do not carry any legal or moral rights to be actively involved with political organizations based in Nepal. It's important here for the readers from other backgrounds to know that Nepal does not permit dual citizenship, and considers one ceasing to be her citizen the moment a person acquires citizenship of another country.

Nepal hangover:

Whether through NAV, NRN or through other sister concern groups. one may wonder, why some of our

> community members still want to continue their active party political life from Nepal in Australia. It appears that their unmet political and psychological needs to be recognized as leaders or just to feel validated , are the driving force for such association formation.

Generally almost non-existent for the community, such organizations

suddenly become active only when a political leader of a specific political party visits Australia, be it on official invitation, attending conference or personal visits. It is really a shame when such leader then proceeds to 'cadre workshop' and probably gets to fuel his narcissistic but fragile ego by being inflated by the people who identify themselves as followers of their political party in Nepal. We have examples that when such leaders visit Australia, they shy away from the mainstream interactions, and productive community debate. They would rather attend cocktail dinners, get some photo taken with a few, with no meaningful impact of their visits. Unfortunately such news are flaunted in Nepalese media here in Australia and back in Nepal. Along with that goes the name of the leaders of those political groups based in Victoria. This probably gives one more reason for the 'cadre' or self proclaimed leaders of the overseas branch of the Nepalese political parties to strive for such positions and justify their existence. One may argue that those organizations carry out charitable

activities or contribute to good causes. But the point here is why we do not need so many new organizations, whereas we can already do those things through the existing ones like NAV and NRNA. To me, forming these sister concern groups of these political parties in Australia is meaningless and just a way to serve few people's personal ambition to rise in social portfolio.

Introspection:

Why am I so critical of the above phenomena? There are two main reasons - the first is that it is not letting us as a community to rise beyond petty politics and dispute that are based on what they believed when they were in Nepal. Few examples are: development of a core group in the recent NAV election and seeking votes in a clandestine manner, the political groups' common demand of 'shares' when it came about NRNA election just over a year ago, and also in some other community activities or projects. Would not they appear more genuine if they would like to come forward as an individual, when such activities are clearly driven by individual forces from different walks of life joining together as a common cohesive force? I am however more concerned by the second reason - being wrong examples to our children and being wrong role model by showing them a direction they are very less likely to pursue. When rest of the Australian community gets involved in Australian politics, are not we depriving our children, and more so ourselves too, from opportunities to assimilate. We still can preserve our uniqueness, and we will be better Australian Nepalese, if we accept who we are at the present, and get out from hangover of the past.

We need to get out from Non-resident psyche to Australian resident psyche. If we consider living in this great land for good, by not making this transition, we are doing a disservice to the next generation of Nepalese Australians' integration to the broader Australian Society and depriving them the full opportunity to move towards decision making and leadership positions in Australia.







Fiction staged in Nepal



by Philip Pullman



by Clive Cussler



by W. E. Bowman



The Oriental Casebook of Sherlock Holmes



The Mountain is Young by Han Suvin



And so, I offer my Chocolate Zucchini Mini-Cakes to you, as below. Some of my mates who tasted these cakes asked "Why Zucchini??.... is that your way of saying its veggies.. so is healthy?. My answer "Well... Zucchini... cause it's a change from the norm and a lot more

CHOCOLATE ZUCCHINI MINI-CAKES





Ingredients:

- » 120 gms Butter
- » 1/2 cup Vegetable Oil
- » 1 3/4 cups Sugar
- » 1 teaspoon Vanilla Essence
- » 1 teaspoon Baking Soda
- » 1/2 teaspoon Baking Powder
- » 1/2 teaspoon salt
- » 2 large eggs
- » 1/2 cup Greek Yoghurt

- » 2 &1/2 cups All Purpose Flour
- » 3/4 cup Cocoa
- » 2 teaspoons Coffee, optional.
- » 2 cups Shredded Zucchini
- » 1/2 cup Chocolate Chips

For the Chocolate Ganache:

- » 170 gms of Heavy Cream
- » 250 gms of Chocolate Chips

Recipe:

For the Cake:

- » Preheat the oven to 180 degrees and line a baking tray you would like to use.
- » In a large bowl, cream the butter, oil, sugar, vanilla, baking soda, baking powder, and salt. Beat in the eggs one at a time. Finally, stir in the yogurt alternately with the flour.
- » Add the cocoa and espresso powder and mix till smooth.
- » Finally, fold in the zucchini and 1/2 cup chocolate chips.
- » Spoon the batter into the prepared pan. Here, you will have to be careful with the baking. If using muffin trays, bake for 8 mins initially and then check with a toothpick if baked. If it comes out clean or with only little bit of crumb, it is done. If using a larger, single tray, bake for about 20-25 minutes first and then do the Toothpick Test. Once, done, cool on a rack.

For the Chocolate Ganache:

- » To prepare the frosting, heat the heavy cream in a saucepan over medium heat until simmering.
- » Remove from heat and pour over the chocolate chips. Wait 3-5 minutes and then stir to combine. This will gradually thicken.
- » When warm pour over Cake/ Muffins and smooth with offset spatula. Allow frosting to set for about 30 minutes before serving

Dassanayake returns to Nepal

epali national cricket team coach Pubudu Dassanayake returned to Nepal, Thursday last week ending any uncertainty over his new term. After the Cricket Association of Nepal (CAN) announced not to retain him sighting financial inabilities on June 30, the government stepped in to hand the coach one-year contract extension on July 2.
