

## **Editorial**

#### NRNA's disenchanting electoral system

Nepalese Diaspora is deciding on its fate this month by electing a new leader in Non Residential Nepalese Association's general convention happening in Kathmandu. NRN members from all around the world are set to travel to Nepal to vote for the candi date of their preference. But many were left despondent for not having recieved a chance to cast their vote owing to NRNA's electoral mechanism

NRNA has allocated Australia chapter 100 seats and to get into the quota was a battle on its own for our potential voters. NRNA chose its representatives to go to the convention in Nepal via online nomination that was literally open for fifteen minutes. Initially opened for three days, the polling was closed within minutes as enough number of people nominated in first in first serve basis

This has raised concerns about the demo-cratic aspiration of NRNA as an organisation and the inadequate electoral system just seems to be an image of Nepal's political culture. Yes, logistically it is not possible to take each and every NRNA member to the convention and the representatives that did get to go, are perceived to have been given the mandate, but the election process could have been better.

The whole idea of election is supposed to reflect the weight of the public opinion, consideration of popular interest and broad representation of social, economic and political concerns of its stakeholders, but NRN's current electoral mechanism is far from incorporating the native reality. The fundamental rights and participation of NRNs have gone amiss. In order to attract public confidence, NRNA activities especially around the election process must be transparent. Tired of flaws in existing system and the growing disenchantment towards the NRNA and its functionality, Australian Nepalese now seek more acceptable method of electing representatives. # **Election-Lesson for Nepalese community**

Record number of South Asian candidates Time for us to give it a go!

ustralia had its 44th general elections on September 7th to the House of representative and senate under the Commonwealth of Australia Constitution Act, 1900. In this election, Liberal and National Liberal won 58 and 22 seats respectively making it 90 for Liberal National Coalition giving 35 seat advantage against the opponent Australian Labor Party. Subsequently, leader of the Liberal National Coalition, Tony Abbott has been sworn in as a Prime minister of Australia for next three

In the history of Australian elections, two major parties Australian Labor Party and The Liberal Coalition have dominated the lower house. Since the foundation of the Liberal Party in 1944, these two groups have formed every government and this year was no different.

#### **Number of Political Parties** proliferated

This election Voters got spoiled for choices as the number of registered political parties have more than doubled since the 2010 election, and is at a record high. Many termed the proliferation of parties a triumph for democracy, and the other called it opportunistic individuals and groups seeking publicity. More political parties were registered to contest the federal election than ever before, with the Australian Electoral Commission approving the most applications since party registration was introduced in 1984. As the entry criteria made too easy 24 more parties registered with Australian Electoral Commission than Federal election

With some interesting names and manifesto, parties like Fishing and Lifestyle Parties, Motoring Enthusiast Party, Australian Sports Party, Bullet Train for Australia, No Carbon tax Climate Sceptics and shooters and Fishers Party took part. Some even voted for Australian Sex Party, Coke in the Bubblers party, Help end Marijuana Prohibition party, Smokers Right Party or Pirate Party Australia. Amongst the new entrants the Palmer United Party and the Katter's Australian party left its entry mark in Australian politics with one seat each in their hand.

And while 54 registered political parties may be a record high, given the two-party system and the rarity of minority governments, it's still low when compared with some other countries.

#### Record Number of South **Asian and Subcontinent** candidates

DECLARED

This year's election remained quite significant for Asian and Subcontinent community as we witnessed largest number of candidates from the region actively participating in the election. A total of 26 candidates from

South Asian origin stood up in the election representing different political parties or as independent for the seats of both houses This number may not seem big compared to the wide range of political platforms across Australia; but this certainly indicates the increasing Subcontinent interests in mainstream Australian politics.

A total of 26 candidates from South Asian origin stood up in the election.

Both major political parties made an attempt to inculcate South Asian candidates in their election campaign. Labor intended to capitalise on voters by recruiting Manoj Kumar from Menzies in Melbourne for lower house and Bhupinder Kumar from Chibber in NSW for senate. Liberal however had four South Asian origin candidates jostling for the seat in parliament, three of them from Victoria. Green also had four candidates running for them, the most prominent being Alex Bhathal from Batman electorate from Melbourne's North.

Interestingly enough it is the newer and lesser known parties that had stronger presence of South Asian candidates representing them. Newly registered Palmer United Party had nine and the WikiLeakes Party had two Subcontinent origin candidates standing in the election.

# We can give it a go!

Despite increasing South Asian representation in mainstream Australian politics, no Nepali has yet risen up to this challenge. As the fastest growing community in Australia, it would have been timely to see someone from the community advancing into the mainstream political platform to voice our concerns to a government level.

"We are relatively new in compared to other South Asian Community, most of our population is a first generation migrants and has survival as the first priority however we don't lack intelligence, awareness and education to compete and integrate into Australian politics. It is now the need of hour that someone begins chipping it away" says a community leader.

A political science student from Latrobe University says "the awareness of political participation is directly related to the history of migration. Lack of familiarity with the political system would translate into lack of participation." In our case, we have hundreds of Nepalese who have made noteworthy achievements in businesses and academia many hold extensive backgrounds and distinguished careers, we have produced hundreds of affluent personalities but we are lagging political participation.

That said, off late we are starting to see many Nepalese youths showing promises leading the community. And that is a step closer for us to be able to capitalise on the democratic platform provided by our adopted country, the great nation Australia. We can do this and all we need to do is to give it a go.

Unlike in the US where many Nepalese have gained clout in mainstream politics, such as Darshan Rauniyaar who ran for congress in 2012 election, we are still to have the privilege of voting for a Nepali candidate in Australia. As a community we are hungry for the real leadership. Hopefully the day comes sooner than it looks.

# Dashain Facade

For Nepalese living overseas Dashain brings a range of emotions. In one hand it's a time for celebration but on the other, it becomes the time they yearn home the most. Especially the ones without a family are saddened as they miss those times spent with the family and friends.

jobs get created and more importantly people don't mind splurging a bit extra for the occasion.

Besides fun and entertainment, Dashain also becomes a time to forget all the bitter experiences of life and enjoy taking blessings from the elders and feel blessed. The bonds between the relatives are tightened the family gets united.

#### **Current practice**

Animal sacrifice is one of the most important and debated aspect of this festival. While many social groups around the world

#### Perception and significance

As the first chills of winter approaches most of Nepalese Hindus prepare for Dashain, country's longest and most auspicious religious festival. This fifteen-day celebration takes place during the month of Ashwin or Kartik on the Bikram Sambat calendar (between late September and early October) during a bright lunar fortnight ending on a full moon day. Dashain is the biggest hindu festival in Nepal that is celebrated commemorating the victory of good over evil, triumph of virtue over sin or immorality. Besides indulging in fun aspects - mouth-watering feasts and endless merrymaking through kite flying, playing swing, reunion with family members, get together with friends, shopping, receiving dakshina and blessings and playing cards - the 15-day long Dashain is a festival that is celebrated observing interesting rituals most of these based on religious stories associated with this festival.

According to the legend, Dashain is celebrated in memory of a bloody battle between Goddess Durga and demon Mahisasur. As the demon had created troubles for human-kind, the goddess fought with him for nine days in her nine different incarnations. But it was on the 10th day, she got victory over the demon. And this 10th day is the day of Tika, the main day of the festival.

Meanwhile, there is another myth from the Ramayana according to which Lord Ram in Treta Yug had killed 10-headed Rawan. People enthusiastically celebrated this victory of Lord Ram over the devil Rawan. And the celebration was during the time of Dashain.

#### Worshipping Shakti (Power)

Dashain is celebrated for 15 days, each day carrying its own value. The first day of Dashain is Ghatasthapana. On this day, the symbol of Shakti is established in hindu household.

And from the day of Ghatasthapana till

Nawami (the ninth day of Dashain), different incarnations of Goddess Shakti are worshiped. The goddesses Shailaputri, Brahmacharini, Chandraghanta, Kushmunda, Iskandamata, Katyani, Kalaratri, Mahagauri and Siddhidatri are worshiped from the first to the ninth day respectively.

Dashain has important religious aspect as we worship Shakti (power) and different forms of power during this time. And the metaphor of this religious ritual is that the life would not exist in this world without power. Thus, Dashain symbolically educates people about the importance of power in our life and also the fact that goodness always prevails over bad.

Without Shakti (power) there is no creation. Worshipping and praying Shakti help humankind to gain good fortune, happiness and prosperity not only in this world but also in our afterlife.

It is believed that human beings worship different incarnations of Shakti to remember and inherit the characteristics of those incarnations in human life for good impact.

#### The rituals

After Ghatasthapana, another important day of Dashain is Phulpati. It is observed on the seventh day where "a collection of sacred flowers, shrubs and fruits like Ramba (banana), Kachhi, Haridra (turmeric), Jayanti (flower), Bel, Darim (pomegranate), Ashoka (fruit), Maankam (herb) and Dhanyadi are placed in the Dashain Ghar of every household" shares Dhungel.

There is also a tradition of bringing Phulpati from Gorkha Palace to Hanuman Dhoka in Kathmandu on the seventh day which is also one of the main attractions of Dashain in Nepal.

The celebration of Phulpati is followed by the day of Maha Astami and Nawami. At night between Maha Astami and Nawami, animals like goat and buffalos are sacrificed at Taleju Temple of Hanuman Dhoka. And the gate of the temple is open for public on the day of



Nawami. However, the feasting starts from the day of Maha Astami in the houses of general people where different animals are sacrificed in various temples of Nepal. And the meat of sacrificed animals is eaten as Prasad, the offering from the goddess.

Then comes the day of Dashami, the main day of Dashain. This is the day when people receive tika(A red mark on their forehead) and blessings from their elders along with feasting and merrymaking. From the day of Dashami till Kojagrat Purnima (the last day of the Dashain), people visit relatives home to put on jamara and tika as well as receive blessings for good health, happiness and prosperity. This full moon day is known as Kojagrata, which means, "one who is awake." At this time, the worship of Durga, in her wrathful aspect ends, and Lakshmi, the Goddess of Wealth, is worshiped for prosperity, happiness and well-being. Life returns to normal, offices open, people go back to work, pilgrims return home. According to Nepalese tradition, those who observe the festival of Dashain acquire virtue, power, wealth and many offspring--even as they escape the miseries of evil and sin.

#### Other aspects

Regardless of its religious aspect Dashain is always most welcomed as the longest public holiday in Nepal. The government offices, educational institutions along with other private organisations remain closed from the day of Phulpati during Dashain. The Dashain vacation gives everyone time for reunion with their family and friends. Dashain is the time where one can visit relatives and enjoy feasting and playing cards together. Millions of overseas Nepalese take a trip back home just for the festival. Economy booms casual

have been acting to raise awareness towards vegetarianism, this festival sees millions of animal get slaughtered in the name of god. People who hold different opinion term this practice as a brutal massacre of innocent animals in the name of celebration.

While giving dakshina is another important aspect of Dashain, people have begun to use this tradition as an opportunity to show off by offering large amount of money as dakshina. Also, because everyone in the family is expected to get new clothes and feast, the head of families are sometimes forced to spend beyond their means to fulfil the desire of the family members and also to maintain a social status. The practice is about giving, however it can be demanding if taken overboard.

#### Dashain in Australia

For Nepalese living overseas Dashain brings a range of emotions. In one hand it's a time for celebration but on the other, it becomes the time they yearn home the most. Especially the ones without a family are saddened as they miss those times spent with the family and friends.

Many Nepalese living in Australia celebrate Dashain with getting together with friends and many seem to atleast do all the rituals that they would if they were back home. With lots of Durga temples around many are expected to pay a visit to them this year.

To commemorate the biggest day in Nepali calendar, many community organisations are holding a Dashain special day locally. Nepalese Association of Victoria, NSW, WA and NT are organising events to exchange wishes and celebrate the goodness of the festival. *Happy Bijaya Dashami!*







#### What is an allergy?

One in three people in their life time suffer from some form of allergy in Australia. Although most allergies are mild to moderate, however anaphylaxis (a form of allergy) can be life threating.

Classical symptoms of rhinitis are – runny, itchy and blocked nose, red and itchy eyes and sneezing. However it can present with many other symptoms such as itchiness, hives and welts in the skin and chest symptoms ranging from irritation in the throat to cough to even asthma attack. It can also present with tiredness, snoring, headaches, loss of concentration and fatigue.

In simple terms allergy can be seasonal (certain time of the year such as in the spring and early summer) or perennial (throughout the year). Seasonal allergies are caused by allergens such as pollens, grasses and usually present with nose and eye symptoms as described above.

Perennial allergy on the other hand is due to animal dander, skin, fur, hair, dust, dust mite, food and food additives. Symptoms are usually persisting. Symptoms can vary from nasal to skin to cough to asthma attack.

# How does your body react with allergens and cause allergy?

This is as a result of your immune system trying to fight off or get rid of substances called allergens that enter your body. Initially your body becomes sensitized with the allergens but at subsequent exposure body's immune systems react, releasing lot of chemicals that bring the symptoms described above. Generally speaking these allergens can be animal dander, pollens, grasses, moulds, dust, dust mite, food, insects and medicines.

# How do you find out that you have an allergy?

If you think that you may be suffering from allergy, visit your doctor for further discussion and diagnosis and management of it. Doctors are able to direct you to right path to help you manage your problem and thereby helping you to make feel better. Diagnosis of allergy can be made by assessing your symptoms, blood test and skin prick testing by your doctor.

#### How to minimise the allergy?

Remember the common causes of allergies as stated above. Following tips are applicable to the list outlined above.

- Pollens avoid windy weather, keep windows and doors closed, avoid outdoor activities during middle of the day when there are lots of pollens, use mask if practicable, have a shower after work or outdoor activity.
- 2 Grasses similar techniques
- 3 Dust mite frequent vacuuming, dusting, cleaning the clothes, avoid old mattresses, be aware of old carpets! Use dust proof pillow and mattress cover if possible.
- Moulds keep the kitchen, bathroom and laundry clean and dry.
- Insects and cockroaches as above and do not leave food outside and keep it in a sealed container.
- Animal dander, fur, skin, hair minimal interaction with pets and avoiding them if you have allergy.
- Irritants such as fumes, perfumes sprays etc can be the causes of allergy. Avoid them as much as possible if you are allergic to them.

# What are general management /treatment guidelines for allergy?

Whilst there is no cure for allergic conditions, it can be well managed with various forms of treatment options. However the treatment needs to be individualised based on his or her circumstances. Your management options will be discussed and outlined by your doctor.

These are some of the suggested treatment options in Australia. Remember preventive measures are very important!!

- Preventive measures as outlined above would minimise your symptoms.
- Nasal sprays, mainly to treat rhinitis (blocked nose, runny nose, itchy nose, sneezing, snoring, associated cough, throat irritation and sinusitis) are very good options. However nasal sprays contain small amount of steroids, hence advise needs to be sought before using it. The duration of usage, amount to be used and frequency needs to be discussed with your doctor.
- Nasal decongestants can be used for short term, only for up to 5 days however

- this is not for people with heart disease or high blood pressure.
- Antihistamine can play a role.
   Nasal irrigation using saline drops or spray can be used as well
- 6. So far the definitive treatment that is available is IMMUNOTHERAPY, which is given in an injection form over a period of time at gradually increasing amount to desensitise your immune system. If a particular cause of allergy can be found this remains the gold standard in terms of treatment options.

Nepal's one of the most prestigious annual literary award, Madan Puraskar has been awarded to poet and writer Rajan Mukarung for his novel Damini Bhir.





# Book Review



## **Finding Neema**

Author : Juliet Reynolds Publisher: Hachette India

Honest, funny and compassionate, Finding Neema is the story of an autistic boy from the eastern Himalayas, brought up by the author and her husband, a gifted Indian artist. Set against the backdrop of the art world in India, and interwoven with reminiscences of her own unusual life and marriage, Juliet relates a compelling story: the couple's unplanned adoption of Neema, son of their maid, Poonam; their endeavours to have his autism diagnosed and treated; and Neema's emergence into adulthood as a valuable - though still dependent - human being. The book also delves into Neema's background and

tormented early life with his dysfunctional family, thereby touching upon some of the more lurid aspects of developing world poverty and introducing into the narrative an assorted cast of characters, some appealing and some appalling, but all of them colourful. Poonam's story of abuse, self-destruction and faltering redemption at once poignant and astounding - forms an important strand of the book and is related with special insight and frequent exasperation. Not only does the author tell a story of autism quite unlike the many already told, she also places it in an Indian and South Asian context.

# **History of Free Knowledge**



tion for the elites at the library. They would dine and sleep in their private quarters within the library premises. The scholars had space and freedom to explore whatever they desired. However, this privilege was not given to all public; woman, blacks, slaves

and children were denied access. There was a separate library known as Temple Serapis "daughter library" for those who did not fit the elite and wealthy class (Whitehouse, 2004)

Our modern day library is indifferent to ancient libraries. This is because we live in a democratic country where we strive on social equality irrespective of gender, social class or colour. Having said this, it was only in the last 50 years that we have moved away from subscription library, gender, colour and class discrimination through rigorous protests by

In addition, access to libraries would not be free if it wasn't for George Brain, an activist for Free Public Library Movement in Australia 1932. He advocated that information should be free to all. Since the Parliament passed the Libraries Act in 1943, it is only fair that Australia joined the Public Lending Right Program (PLR) which ensures that authors are compensated for their books. artwork and music they provide to the public libraries.

In conclusion, having previously bor-rowed books, DVD's and CD's, I feel at ease, that we moved away from society's discrimination of free knowledge and are able to read as many books as I like in the library without any costs. I surely now feel very grateful which is something I obviously took for granted.

## **Aamir Khan's secret trip to** Australia for dance lessons



# ADB to grant \$23.5 million for water supply project in Nepal


The Asian Development Bank (ADB) has approved a \$23.5 million grant from the Strategic Climate Fund for a project that will ensure water supply to about 45,000 households. The project is one of five components of Nepal's Strategic Program for Climate Resilience.

The project will work in watersheds in six districts in the Far-Western Development Region - Achham, Baitaidi, Bajhang, Bajura, Dadeldhura, and Doti - which depend on agriculture but are already suffering water shortages.

Under the project, better water management and storage will be implemented through some 100 community subprojects, which will rehabilitate and protect the areas around water sources in order to improve the

yield of those sources. They may also build water collection ponds and drinking water tanks to storage water during dry months. The project will also educate communities on water conservation practices, including micro-irrigation, methods for maintaining soil moisture in agriculture, grazing and fodder management, and ways to regenerate vegeta-

The executing agency is the Department of Soil Conservation and Watershed Management.On top of ADB's funding, the Nordic Development Fund will provide up to \$4.63 million in complementary technical assistance, and the Government of Nepal will provide \$1.94 million. The project is due for completion in 2020.



## **Handicraft fair in November**

The Federation of Handicraft Associations of Nepal (FHAN) is organising the 11th Handicraft Trade Fair from November 19. The five day fair is expected to provide a common forum for both potential buyers and sellers of Nepali handicraft products.

The FHAN is organising the trade fair in association with the Nepal Trade Integration Strategy programme of the government, the Ministry of Commerce and Supplies, the Trade & Export Promotion Centre, the Federation of Nepalese Chambers of Commerce and Industry, the Micro Enterprises Development Programme of UNDP and the Federation of Nepal Cottage and Small Industries.

According to the federation, a number of handicraft entrepreneurs from India, Bangladesh, Pakistan, Sri Lanka and Bhutan, along with local handicrafts manufacturers, will be participating in the exhibition. The expo is scheduled to house 200 stalls and 10 pavilions, which will be showcasing metal crafts, pashmina products, handmade paper products, felt products, silver jewelleries, natural fibre products, wood crafts and ceramics products to name a few.

The Craft Competition will be one of the major attractions to be conducted during the fair. According to the FHAN, the winner of the competition will be awarded with an attractive cash prize. The FHAN is estimated to attract 100,000 visitors and a turnover of Rs 50 million during the trade fair.

Addressing the 68th UN General Assembly, Regmi said there was no alternative to November 19 Constituent Assembly election for political stability and multi-party democracy. Regmi is slated to meet with Indian PM Man Mohan Singh and UN General Secretary Ban Ki-moon on the sidelines of the assembly Regmi who left for New York on Thursday is schedule to return Kathmandu on Sunday.

Recently in Delhi for the deliberations of the International Buddhist Conference, the MIT trained architect said India has to be a part of the Lumbini project as Buddha lived and preached in India and his heritage could not be divided by national boundaries."The Indian govt and people have a big role to play in redeveloping Lumbini. # "ATTENTION-POWERED CAR"



Australian road safety researchers have unveiled a pioneering "attention-powered car" which uses a headset to monitor brain activity and slow acceleration during periods of distraction.

f you lose attention your car will stops. It sounds strange but this is soon becoming

Australian road safety researchers have unveiled a pioneering "attention-powered car" which uses a headset to monitor brain activity and slow acceleration during periods of distraction. The car, commissioned by the Royal Automobile Club of Western Australia, is about to depart on an awareness-raising road trip of Western Australia -- a sprawling west coast state accounting for about onethird of the Australian continent

Lead researcher Geoffrey Mackellar, from neuroengineering company Emotiv, said the car's accelerator could be overridden by a headset with 14 sensors measuring the type and amount of brain activity which determined whether a driver was distracted.

In the testing phase, drivers were set specific challenges such as using their mobile phone, switching channels on the radio, drinking water or reading a map so that researchers could record their brain activity while doing so. They were also sent on a 15 kilometres per hour "boredom lap" to see what happened when their brains "zoned out" -- "pretty nasty but we enjoyed it", Mackellar said.

"We're looking at things like blink rate, blink duration, gaze rate -- how long they look at a point -- eyes moving, head tilts, and also frequency of task-switching and the level of brain activity when they flick over to those tasks, so it's a huge pool of data," he said.

Although the system could have potential commercial applications, the RAC said their current focus was on research and public awareness.

The impact of inattention is now comparable to the number of deaths and serious injuries caused by speed and drink driving," said RAC chief Pat Walker.

"Nationally, it is estimated inattention was a factor in 46 percent of fatal crashes.'

The Australian government estimates that road accidents cost the economy Aus\$27 billion (US\$25 billion) every year.

# Apple iphone 5s



Apple Inc's newest smartphone models hit stores two weeks ago in many countries across the world, including Australia. The gadget giant for the first time is selling a second smartphone dubbed "5C" featuring a plastic back and bright colors. The pricier "5S" now comes in three new colors - gray, silver and gold.

Technology firm iFixit disassembled a gold-colored iPhone and examined its parts. Following are some of the key components for the iPhone 5S and their makers that have been identified so far:

 Chips from Avago, Skyworks Solutions are featured in the new iPhone. Companies supplying parts for the new phone also include memory chipmaker Hynix and radio-frequency chipmaker Triquint

- The new fingerprint sensor uses a chip from NXP Semiconductors
- There is no single M7 motion co-processor, a new chip that Apple said was part of the iPhone 5S when it unveiled the device last week. The M7 appears to be more a collection of chips, including chips for a gyroscope, accelerometer and compass, iFixit said.
- Broadcom's BCM5976 chip is used for touchscreen controller.
- Murata Manufacturing Co's 339S0205 (based on the Broadcom BCM4334) is used in Wi-Fi module.
- Includes chips from Qualcomm Inc (PM8018 RF power management IC) and Texas Instruments Inc.

# The Global Health Perspective and Challenges: Developed vs. Developing Countries

Nepal will benefit from strong public health policies, increased funding and public education and health awareness programs at the grass roots level to address the prevalence of the most common infectious diseases.

he development and sustainability of the health sector is one of the most challenging areas in the 21st century. A strong health sector is the result of appropriate funding, directed policies and technological advancement. The irony of the matter is, that even a developed country, which flourishes in economic strength, industrialization, governance and a good standard of living still experiences chronic health issues.

Affluence increases the prevalence of health aberrations, including the increased prevalence of lifestyle diseases within the community. In contrast, an underdeveloped country suffers from a lack of basic awareness on health issues including health education and health training as well as access to health services. The extent of this health disparity is clearly represented through the burden of infectious diseases that have become a common entity within developing communities; whilst some of these same diseases have affected developed communities without discrimination.

To draw on the different health perspectives and challenges within developed and developing countries, I will use the example of Australia and Nepal respectively, as these two countries compare well in terms of economy, living standards and population size. Australia is one of the most prosperous and developed economies in the world, whilst Nepal is one of the poorest and underdeveloped economies. The landmass of Nepal is 1/50th to that of Australia, but the population size is almost 2/3rd larger; and more than 25% of the population are living below the poverty line. Interestingly, both economies experience chronic health issues, which are vastly different in nature.

#### Australia's Health Perspective

Most of the Australian cities like Perth, Brisbane, Adelaide, Melbourne and Sydney have a higher average income than London and New York (Economist Intelligence Unit 2012). Alongside the multiple social welfare



benefits, this higher average income is contributing to an affluent lifestyle, which is playing a crucial role in the emergence and continuation of chronic disease.

The most recent Australian Health Survey identified the long-term health priority areas as chronic diseases of lifestyle; including Heart disease, Type II Diabetes and Cancer. The health risk factors responsible for most of these issues included tobacco use, alcohol consumption and obesity (Australian Bureau of Statistics). Importantly, the rates of obesity for both men and women in Australia have increased over time, whilst alcohol and tobacco use still occupy a significant place in Australian culture. It seems that affluence has triggered health issues through lifestyle related practices including over consumption and erroneous standards of living.

Is this standard of living contributing to the better health and wellbeing of the Australian people? One of the most pertinent challenges ahead for Australia is to weigh up the benefits and risks of this economical prosperity linked to Australia's health issues in the near future.

#### Nepal's Health Perspective

Infectious and transmissible diseases remain the largest burdens of disease in Nepal that contribute to high rates of mortality and

morbidity. Some of these diseases include malaria, typhoid, gastroenteritis, intestinal parasites, leprosy and tuberculosis. These health burdens arise mainly form poor public health education, communication and training in fields of hygiene, vaccinations, potable water consumption, clean cooking practices and availability of common medicines. This is reflective of the poor health policies and lack of government funding. Furthermore, rural and marginalised communities have limited access to basic health care and services, contributing to a higher prevalence of ill health and wellbeing.

#### Conclusion

The Australian health system and communities need stronger support in terms of public policy, funding and public education. Community based programs that educate people to liver a healthier life, free from dependency on medications with focus on a preventative health and a change of habit is the way forward. This will reduce the burden of chronic and lifestyle diseases that are the growing cause for concern and cost in Australia's health system.

On the contrary, Nepal will benefit from strong public health policies, increased funding and public education and health awareness programs at the grass roots level to address the prevalence of the most common infectious diseases. Despite the different nature of the health problems between developed and developing countries, we may need a common approach with a focus on prevention and educational awareness to address these emerging health challenges.

or Macintyre, tradition is a necessary context for rationality. He forms the view, in modernity reasoning or reasons has become incoherent. This relates to the notion that modernity is fluid. People cannot come to a reasoned agreement of 'good' and we should look to traditions as forms of coherent reasoning. His work focuses on issues of ethics and social and political philosophy. In his publication "the story telling animals" he outlines the changing societal relations based on fragmented views of identity. Identity for him is about the role individual plays in a narrative.



imperative for Macintyre that we understand our role in the narrative; not understanding the narrative inhibits progression towards their goal or telos. Therefore in Macintyrean school of thought, this person is considered lost. This is a fundamental concept for Macintyre because feeling lost causes anxiousness in individuals. Some of characters of modernity are discontinuity, speed and anonymity. He argues that modernity is fragmented, in



that, society do not depend or relate to any stories to create identity any longer. The need to be independent and self reliant has people breaking from meaningful collective experiences.

Macintyre is a critique for Liberal Modernity. Essentially, we thrive on collective remembrance through our history. Macintyre states, "Man is in his actions and practices, as well as in his fictions, essentially a story telling animal"; and breaking away has caused isolation for individuals. Therefore, revival of traditions would provide a sense of solidarity. The key questions of his theory is "what story or stories do I find myself part"? A person becomes active in his or her actions and experiences that encompass a meaningful life.

In a society such as Nepal, which is fast pacing towards modernity begs many questions. Whether we embrace tradition or abandon the rituals, ceremonies and story-telling to the generation ahead. 



According to the source, During the first phase of project evaluation for adoption, a total of some 17 hydropower projects were considered, out of which, Dordi Khola Hydropower Project having capacity of 27MW was selected. NRN Investment has acquired 51% stake in the project. Feasibility Study and preparation of Detail Project Report (DPR) has been completed.

The construction activities of the project are scheduled to start on Jan, 2014 and complete by May, 2017. Commercial operation Date (COD) of plant is fixed for June 15, 2017. It's said that the other Projects and Investment Prospects are also under consid-

# Asia to have most millionaires by next year





Asia will have the world's largest number of millionaires as early as next year despite the expected tapering of the US Federal Reserve's stimulus programme, according to a report published recently.

With strong growth and high saving rates, the wealth of the region's millionaires will grow by an annual average 9.8 per cent and reach nearly \$16 trillion in 2015, according to the wealth management unit of Royal Bank of Canada

Despite concerns of devaluing asset prices due to capital outflows triggered by Fed tapering, Asia is set to lead the world in the number of millionaires and their total wealth, the bank said in a report prepared with consulting firm Capgemini.

"The region's high net worth population and wealth has increased by 31 per cent and 27 per cent, respectively, since 2007, far outpacing growth in the rest of the world of 14 per cent and nine per cent," George Lewis, group head of RBC Wealth Management, said in a statement.

The number of millionaires in Asia surged by 9.4 per cent year-on-year to 3.68 million in 2012, still trailing North America's 3.73 million. Millionaires in the report are defined as individuals with investable assets of \$1 million or more, excluding residence, collectibles and others

Asia's continual population growth, and economic growth expected to continue outperforming rest of the world, would help it take the lead as early as next year, according to Eric Lascelles, chief economist of RBC Global Asset Management. He said the Fed's tapering plan could create 'hiccups' but would not affect the trajectory of growth in the region. The bank said Japan saw the slowest growth in its millionaire population last year among Asian economies.

# **ATO** to scrutinize "cash in hand" business

ustralian tax office is set to crack down on cash-in-hand payments, targeting especially blue collar workers in its quest to catch out cheat. As its time for Australians to fill out their tax returns, the Australian Tax Office has revealed its hit list for professions in the crosshairs. High claims by building and construction labourers, construction supervisors and project managers as well as sales and marketing managers. The hospitality and carpentry industry will also come under scrutiny for failing to pay employees their superannua-

tion entitlements. According to the source, small business hiding their income by paying their employees cash will be under the microscope.

Last financial year GST compliance work including reviews and audits of small and medium businesses resulted in the ATO raising \$587 million in GST liabilities

The ATO data-matches more than 640 million transactions each year from

sources including banks, share registries, employers, merchants, states and territories and other government departments. Last year data and information matching raised \$973 million in revenue adjustments from about 450,000 reviews and audits.

In the 2011-12 financial year the ATO transferred more than \$275 million of employer super contributions to members accounts after compliance action and this year expects to contact around 19,500 employers as a result of these complaints.



# Nepal's growing **AD industry**



The volume of Nepali advertisement market has crossed Rs 4.50 billion due to the rise in trend of promoting goods and services. The volume of advertisement market including that in print and electronic media, online and outdoor has crossed Rs 4.50 billion in the fiscal year 2069/70 with a growth of Rs 200 million in comparison to the preceding year, according to the Advertising Association of Nepal (AAN). It is expected to rise beyond Rs 5 billion during the current fiscal year.

A whopping 47 percent of the advertisement pie is shared by the print media, 25 percent by television stations, 17 percent by radio stations and the rest 11 percent by outdoor advertisements. September and October are the months with the highest flow of advertisements while December and January the lowest, according to Bhattarai. The period starting from a month ahead of Dashain till Tihar sees the most number of advertisements published/broadcast and produced.

The Nepali advertisement market is growing by around 10-15 percent every year, according to AAN. Service sector contributes 60 percent to the industry and goods 40 percent. Banks, financial institutions, insurance companies, telecom companies, schools, colleges and manpower agencies in the service sector have increased advertisements. Advertisement of service sector is more in print, electronic and outdoor with the most pressure in print media, according to the advertising agencies.

With this victory, Nepal secured its place in the AFC U-16 Championship to be held in Thailand in 2014 being the winner of Group C with seven points.


#### Rewati Smriti Cup-2013 to be held
