### **Editorial**

### **RIP Madiba**

Nelson Rolihlahla Mandela, who freed South Africa from the shackles of apartheid to multi-racial democracy and became an international icon of peace and reconciliation, passed away last week.

The whole world has joined South Africans to pay last tributes to Nelson Mandela who remains the most inspirational leader for his nation but his iconic dimensions transcend the South African borders, earning him the global reverence and respect.

Nelson Mandela spent most his life fighting for equality, justice and freedom in a nation where the reign of apartheid-era tormentors ruled with racial segregation, suppression and division. He had built a steely determination to fight against this injustice meted out on the basis of the colour of skin and bring about equality for all South Africans.

He launched and spearheaded a campaign under the banner of African National Congress (ANC) that sought to establish a system where every citizen could enjoy equal right regardless of colour and class. Mandela languished in jail for 27 years, spending the prime of his life behind bars for the lofty cause of the nation and the people. He was ready to face every hardship as his supreme duty of liberating the suppressed people demanded. Mandela said "I have cherished the ideal of a democratic and free society in which all persons live together in harmony and with equal opportunities. It is an ideal which I hope to live for and to achieve. But if needs be, it is an ideal for which I am prepared to die."



Mandela is revered the world over as a champion of social justice and human rights. Current World leaders have taken inspiration from him to lead their struggles for people's rights. After he was freed from jail in 1990, the post-apartheid election held in 1994 made Mandela the first democratically elected president of South Africa. The democratic transformation was hailed for its peaceful ways. A notable quality of Mandela was that he did not intend to impose black supremacy over the white rule. What he liked to ensure was equality to every citizen. His policy towards the whites was that of reconciliation and tolerance.

Leaders who tend to cling to power until they destroy the nation, have to learn from him. To the wider world he represented many things, not just an icon of freedom but also the most vivid example in modern times of the power of forgiveness and reconciliation. Despite his long incarceration, Mandela not only

## Bridging the gap

#### Multicultural Victoria

The state of Victoria is home to one of the most culturally, linguistically and religiously diverse communities in the world. In the hundred years since the first National Census, the multicultural nature of Australian society has developed and grown significantly - especially the state of Victoria where the population is among the fastest-growing and most diverse in Australia.

At the 2011 Census, out of the total population of over five millions, 26.2% of Victorians were born overseas in more than 200 countries with an increase of 23.8% since previous census. The census also said 46.8% of Victorians were either born overseas or have at least one parent born overseas with an increase from 43.6% since 2006. Similarly 23.1% of Victorians spoke a language other than English at home and 67.7% of Victorians followed 135 faiths compared to 68.7% following 130 faiths in

The diversity of such rich cultures has contributed significantly to Australia's socio-cultural and economic development. There are many outstanding individuals and organisations that enrich Victoria as a state through their diligence and hard work to promote the benefits of diversified society and to promote Victoria's reputation as a thriving cosmopolitan city. Furthermore, Victorian Government distributes variety of multicultural awards every year through Victorian Multicultural Commission to acknowledge these individual and organi-

### Victoria's Multicultural Awards for Excellence-2013

This year, Victoria's reputation for embracing multiculturalism was celebrated at The Victorian Multicultural Commission's 2013 Multicultural Awards for Excellence. The awards originally established in 2002, are provided across ten categories, including Meritorious Service to the Community, Service Delivery to Multicultural Victoria, Media, Local Government, Education, Police and Community Multicultural Advisory Committee Award and a Business category. Out of more than two hundred nominations, Victorian Government honoured 77 people and 23 organisations this year, amid the program held at Government House that was hosted by His Excellency the Honourable Alex Chernov AC QC, Governor of Victoria.

## **Community celebrates** the recognition



## Widowhood no more a 'sin of omission', says Anjana

s. Anjana Regmi, Doctoral Candidate of UTS, organised an event 'Rethinking Empowerment of Widows in South East Asia Pacific (REW-SEAP), on Friday, 22 November 2013 at University of Technology, Sydney. The event was organised to raise awareness towards protecting such 'stigmatized' group of women and to publicize the most hidden and veiled areas of violation of women's human rights, especially in the third world countries.

Speaking on the occasion, Ms Regmi drew attention to the lack of a reliable data and research on this sensitive issue, the

Group Nepal in so many developing countries, the lives of many widows, especially rural ones, are determined by discriminatory interpretation of religion, custom and tradition in spite of the enactment of modern laws that comply with international conventions such as CEDAW.

The event commenced with the opening performance by the team of Digital Key Production followed by traditional lighting of the lamp by Mr Mana KC (Spokesperson NRNA-ICC); Hon Deepak Khadka, Consulate General and Ms Sumitra Bista (Coordinator, Nari Nikunja Australia). The







absence of which obstructs planning and implementing effective actions to improve the living conditions of widows across the world. She also shared her experiences of her journey in the social red movement of Nepal through the presentation 'Reflection of my Journey'.

The program also leads up to 16 Days Campaign as a side event of 4th Australian Council for International Development, University Network Conference. The Centre for Women's Global Leadership (CWGL) launches the 16 Days of Activism Against Gender Violence Campaign each year. The 16 Days Campaign that began on November 25, the International Day Against Violence Against Women, will end on December 10, International Human Rights Day. These dates symbolically link violence against women and human rights, and emphasise that such violence is a human rights violation.

To mark 16 Days Campaign, an event focusing on single women's issues was supported by different stakeholders because of the fact that with 245 million widows around the world, the single women (widows) are still fighting for their basic human rights (Loomba Foundation). The customary practices and discriminatory legal provisions continue to deprive widows of their

basic human rights and are a "living sati" in India and Nepal. Widows are forced to face discriminatory laws and customary practices, resulting in the lack of inheritance, restrictions on diet, mobility, social networking and education. According to the Population and Housing Census 2011, out of total 498,606 single women (widows) 370,687 are below the age group of 10 years, which is 5.30 per cent of the total population of single women and remaining 75 per cent single women got married in between 10 to 19 years of age. These alarming data is an evidence of the urgency to address the issue. According to Women for Human Rights, Single Women's

Centre for Women's Global Leadership was the global organiser; the event was hosted by UTS: Cosmopolitan and Civil Societies and UTS: Institute for Sustainable Futures.

The program was chaired by Dr Bronwen Dalton- Chair of the event/ Director of Masters in Not- for-Profit and Community Management, who summarised the session with a note that it is essential to continue to educate the governments and international agencies on the issues of violence against women; and to work on evidence based research for the policy analysis and changes at a national and an international levels.

## **High expectations** from few women in CA

s ten directly elected women members of the Constituent Assembly take parliamentarian oath in December, they will have to remember that they have a responsibility of being torch bearer of the cause of political competition and inclusive politics in Nepal.

The ten MPs will have to do what 30 MPs did in the dissolved CA. Although they will be joined by other women MPs elected under the proportionate representation system, the number of female MPs in the newly elected House will not be as impressive as in the previous CA.

The issue of 33 percent participation of women in parliament in Nepal received a setback this time as political parties offered few women - candidates in the First Past the Post (FPTP): 71 in 64 constituencies. Only ten of them won the election. They include six Nepali Congress candidates: Sita Devi Yadav, Kiran Yadav, Sharada Poudel, Gyan Kumari Chhantyal, Parbati DC Chaudhary, and Sushila Chaudhary. Among the three winning on CPN UML ticket are: Manju Kumari Chaudhary, Nazma Khatun and Sita Giri Oli. Omsari Gharti is the only female candate directly elected on UCPN-Maoist ticket.

The previous Constituent Assembly (2008-2012), despite its failure in various fronts including the completion of constitution writing, had heralded a new age of what experts prefer to describe as inclusive politics in Nepal. It had 191 women- members in 601-member House; 30 of them directly elected and 161 picked up through election based on proportionate system.

There are various reasons why the number of women in the newly elected CA declined. One of them is: political parties' indifference in allowing women's leadership to grow at the constituency level. The other is: leading women's disinterest in facing electorate directly and preference for comfortable way of being MPs.

The directly elected women should be effortful in promoting women to face competitive politics in various districts and

election - constituencies. If this is not done this time, the talks of ensuring 33 percent participation of women in legislature will be simply confined to talk and seminar rooms. Those who enter CA through PR system should also make special efforts in encouraging women to be competitive in politics.

Women's rights activists expressed worry over non-continuity of 33 percent participation of women in CA this time at a recent seminar in Kathmandu. They underlined the need to have a legal framework that ensures 33 percent participation of women in legislature under the leadership of newly elected women in CA.

## Victoria will expand its focus on opportunities with South Asia: Premier Napthine

ictorian Premier Denish Napthine has said that the state government aims for boost in Southeast Asian businesses. Mr Premier was speaking at the Multicultural media conference held in Melbourne on 24th of November, where he spoke at length about Victoria's diverse economy and future prospects. Referring to the Victorian Government delegation last June to Malaysia, Indonesia, Singapore, Thailand and Vietnam, Mr Premier said "as the South Asian century is unfolding we are focusing on opportunities with countries such as India, China and other south east Asian countries."

Mr. Premier expressed satisfaction on Victoria's economic growth and presented a snapshot of Victoria's status in different financial aspects. He added the fact that 14,200 new jobs were created in Victoria last month which is higher than any other Australian states. The Premier Further said "Since I have come in to the office in 2010, 73,400 more Victorians are in jobs".

Citing Standard & Poor's report that confirmed triple A credit rating on financial management, the premier said the state has now the strongest finance in the nation and moved on a record \$6.1 billion infrastructure program to keep pace with the population growth as well as record funding for ambulance services, school education, transport and police force. In less than three years we have increased public transport, today there is a 1078 extra train services each and every week in Melbourne.



However, he called east west link a game changer that will be the counter piece of future infrastructure.

On the big picture is having a pipeline of the key infrastructure projects that will make a difference to Melbourne and Victoria. The first one is a regional rail project which is work being largely done in the west of Melbourne. The project involves 3500 people and 25 million a week. It provides a

## Nepali Mandate 2013

A few lessons that political parties should draw from the mandate of the people is that they should not engage in the game of power-politics or the arm-chair politics of changing or retaining or capturing government every now and then. People are already tired of the drama of squabbles among parties over appointments and power-sharing.



epali voters evinced a sense of courage, maturity and political wisdom as they elected a fresh Constituent Assembly (CA) on November 19, 2013 to finish the task of scripting the constitution for the Federal Democratic Republic of Nepal and to set up a representative parliament. By doing so, they have refurbished the foundation of the legitimate system of democratic governance in the country.

People exercised their right to vote bravely in uncomfortable circumstances marked by boycott the poll-call from Mohan Vaidya -led Maoist-33-party alliance, its ten day transport strike and frequent bomb explosions rocking various parts of the country. Over 78 percent turn - out in the election, besides being impressive and historic, is an expression of faith on electoral process.

More interesting is the mature verdict that voters delivered. They reshuffled the positions that the three big political parties UCPN-Maoist, Nepali Congress (NC), and Communist Party of Nepal Unified Marxist Leninist - had in the previous CA. The UCPN (M) got demoted to the third position while NC and CPN UML were promoted to the first and second position respectively.

The judgment of the people indicates: penalty for UCPN (M) for failing to play properly its role of single largest party in the previous CA. The way people felt let down by the manner in which the party performed in its 25-month rule (first: during 18 August 2008-25 May 2009 under Prachanda -Premiership and second: during 29 August 2011- 14 March 2013 under Dr. Baburam Bhattarai -Premiership) may have given the people sufficient reason to push down the party's position.

Two specific moves that the party leaders undertook in May 2012 also made the people really frustrated and pushed them to reject leading role to UCPN (M). The first related

to Prachanda's double stand in relation to federalism. Switching over from the Jestha 2068 B.S.- Hattiban resort agreement providing for multi-identity and capacity based 11-province federalism, he started re-advocating federalism based on single ethnic identity towards Jestha 2069 (May 2012). Then he urged ethnicity-based organizations to launch movement for it. This made people really worried. The November 19-election slogan of UCPN(M) - federalism with identity, and constitution with federalism - further fueled their confusion. This made them take back the type of election - support they gave him in 2008.

The second refers to the then Prime Minister Dr. Baburam Bhattarai's political inaction on May 27, 2012. People expected him to act as a responsible Head of Government of the country and avoid dissolution of CA. They felt helpless as he pushed the country into constitutional vacuum by not taking any meaningful last minute step to keep CA animated on that date. The experience did not allow voters to re-trust UCPN-M.

The choice of people demonstrates: opportunity for the two political parties (NC) and CPN UML to complete constitution-writing process. The parliamentary behaviour and tolerance that they demonstrated over the past two decades and their history of capability to produce a constitution within a year after the 1990-People's Movement -I may also have played a role in their earning of people's confidence this

The ruling of voters is clear and focused: produce a constitution in one year; complete peace process; end political uncertainty by providing a stable government; create an atmosphere suitable for undertaking economic development works to meet the aspirations of people. The two parties could do it if they work with political wisdom. They do have the capacity to mobilize other parties in CA for having two -third majority needed to adopt constitution.



Inherent in the people's prescription are some strong messages for political leaders. One is: introduce federalism without damaging the fabrics of Nepali unity and nationality while another is: drop the issue of federalizing the country on the basis of ethnic identity, language and regionalism for they are not practically relevant in present day Nepal.

A few lessons that political parties should draw from the mandate of the people is that they should not engage in the game of power-politics or the arm-chair politics of changing or retaining or capturing government every now and then. People are already tired of the drama of squabbles among parties over appointments and power-sharing.

They should not make the legislature-activities of CA adversely affect the task of writing constitution in CA. Members should not allow the tendency to script constitution outside the periphery of CA floor. They

should not turn the consensus - way of taking decision into a way of evading decision

What needs to be done as per the people's expectation is: offer a stable inclusive government and begin wholeheartedly the task of scribbling the constitution utilizing the experience of the CA-I. Members have to voice for all the marginalized, disadvantaged, the deprived and the unrepresented sections of country's population besides representing the grievances of various communities and regions. The political parties should take the responsibility of avoiding discriminations of all types in society and making citizens feel practically connected with the state.

### Challenge

What needs to be avoided is the legacy of failure of the previous CA. All members should be aware of one or the other move that aims at not allowing fresh CA to concentrate on constitution and governance. Some

could engage CA in unnecessary politics and compel it to divert its time and resources on them for making it a failure ultimately.

Those who could not emerge winners have already started accusing the Election Commission of not being fair in election and allowing various types of rigging. The UCPN-M, which emerged third in the election, joined the move against CA poll 24 hours after vote-counting began. It did not allow its winners to celebrate victory for nearly a week. It has already made its entry into CA conditional.

"The majority clause of the constitution for forming government and taking decision should be replaced by consensus clause for our joining the CA," the UCPN -M demanded publicly on November 25. More excuses may follow in future to disrupt the CA.

The election process of November 19 CA poll has been described as free and fair by observers - national and international. Even the party which championed the boycott of CA election - CPN-M led by Vaidya - has expressed willingness to join new government and enter CA through appropriate constitutional mechanism. The gesture expressed publicly by C.P. Gajurel, Vice-President of CPN-M, on November 26 in Kathmandu is a recognition of the CA election and respect for people's mandate. It could be instrumental in bridging the political differences between the two political forces: pro-CApoll parties and anti-CA-poll parties.

The new government and new CA leadership do not have a rosy path ahead. The challenges confronting them can, however, be met if they sincerely follow the pledge they made during the election and the messages


"It was wonderful news, especially on my birthday," Sneha said.

# **CAB** industry

ccording to a recent statistic, Indian born cabbies have out-numbered the Australia born taxi drivers. This multicultural milestone will be the first time that Australian-born workers in a major occupation have been outnumbered by workers from a single overseas country.

While Australian-born workers make up less than half of all workers in low-paying, manual professions like sewing machine operators and clothing trades workers, Australian is still the most common nationality among those employees. However the most popular country of birth of automobile drivers - made up of cabbies and chauffeurs - is set to become India in the next year.

Between 2006 and 2011, Australian-born automobile drivers - made up of taxi and chauffeur drivers - declined by around 1400, while Indian-born drivers increased by more than 4000 according to the ABS Census.

Sometime in the next year, Indian-born automobile drivers are scheduled to outnumber drivers who are Australian-born. The shift is significant. As a comparison, in 1966 there were a relatively high number of UKborn manufacturing workers in Australia. Yet Australian-born manufacturing workers still outnumbered Brits more than five-to-one.

## Mahindra to launch 3 small passenger planes in 2-3 years



ajor utility vehicle maker from India major Mahindra & Mahindra is ■ now looking to take over the skies. The company, which acquired Australian companies Gipps Aero (aircraft maker) and Aerostaff (parts maker) in 2009, wants to change the aviation scene in India with its small aircraft.

Its 10-seater turboprop airplane is expected to be launched sometime in mid-2014, while the 5-seater CNM5 aircraft (jointly developed with NAL) is currently

undergoing certification tests and is likely to be launched in 2015. The company is also modernising an existing 18-seater aircraft, which is likely to be ready within three years.

The group currently sells only one aircraft – the Gipps Aero single engine 8-seater GA8 Airvan - 200 units have already been sold worldwide, but there are already 5, 10 and 18-seater aircraft under various stages of developments, and these will be rolled out over the next 2-3 years.

## ADB to provide Rs 2.9 billion for hydropower

he Asian Development Bank (ADB) agreed to provide a grant assistance of US dollars 21 million to the Government of Nepal for the development of hydropower sector.

The Ministry of Finance in a press release issued last week said the assistance would be used for the implementation of the Project Preparatory Facility for hydropower projects. An agreement to this end was signed amidst a programme at the Ministry of Finance

The objective of the Project is to support the 10-year roadmap for hydropower development with an aim of generating an additional 10,000 megawatt of hydropower.

Large reservoir type hydropower projects are said to be helpful to achieve the above mentioned objectives. The proposed project preparatory facility aims at developing large reservoir storage hydropower projects.

The grant assistance will also be used for environmental examinations, environmental impact assessments and social impact assessments of Sunkoshi 2 (1110 mw), Sunkoshi 3 (536 mw) and update of feasibility study with detail engineering studies of the Dudh Koshi (300 mw) hydropower projects which are expected to be helpful in addressing the problem of energy crisis in the country.

The total cost of the Project is estimated at US dollar 26.25 million and the Nepal Government has to contribute 20 per cent of the total cost mostly in the form of taxes, duties, office accommodations.

The project is expected to end by June 30, 2019. Joint Secretary at the Finance Ministry Madhu Kumar Marasini and ADB Country Director Kenichi Yokoyama signed the agreement from their respective sides.



## (Excess Body Weight)

## >>> Why is it a concern?

#### Introduction:

This article intends to provide some of the important aspects of overweight and obesity, its implications to our health and wellbeing and important practical steps that can be taken from very early age to avoid greatest risk factor for chronic disease burden such as diabetes, high blood pressure, stroke, heart disease, chronic kidney disease, arthritis, and poor quality of life, just to mention few.

After US, Australia has the highest prevalence of overweight/obesity in the developed world; something we should be least proud off. Currently 60% Australian belong to this category and it is expected to rise to 80% by 2025. On the other hand prevalence of overweight and obesity is roughly 15-20% in third world countries. Alarmingly, about 25% of Australian children and adolescents are either overweight or obese. This means we are getting fatter and unhealthier! a sobering fact.

In economic terms the estimated direct and indirect cost to manage overweight/obesity and its related complications for Australian society is predicted to be \$100 billion in 2013.

#### What constitutes overweight/obesity?

Overweight/obesity is assessed by body mass index (BMI) which is calculated by using a formula where your weight in kilograms is divided by height in meter squared (weight in Kg/height in meter x height in meter). According to WHO criteria, BMI <25 is normal, 25-30 is overweight, >30-40 is obese and >40 is grossly obese. However obesity also has another factor that needs to be considered. This factor is waist circumference (our belly size). In men WC <94cm is normal whereas <88cm in women is normal. Larger the WC higher the risk of health problems! Waist Circumference calculations are based on western data and it may not be fully representative to our Nepalese population.

### Causes of overweight/

A range of factors can cause overweight and obesity. Factors in early childhood and

adolescence are particularly important. It is known that breast feeding babies are less likely to be overweight or obese later on in their life. High proportion of overweight/ obese children and adolescence grow to be obese in adults!

Other factors known to increase the risk of obesity include:

- 1. Food consumption related eating excess calories, high content fatty food, processed food (they are high in salt and sugar) and wrong food, poor timing and large portion of the food. Remember processed foods are packed with high calories and have poor nutritional
- 2. Inactivity sedentary lifestyles computers, games, increasing time spent indoors, televisions, usage of cars etc.





#### Some of the steps that can be taken in consultation with our doctor and dietitian are:

- 1. Avoid overfeeding and feeding high calorie, processed food to your children such as takeaways and fish and chips. Breast feed your new born as much as possible.
- 2. Engage our kids in activities such as sports, parks and outdoor activities instead of letting them watch TV or play games.
- As parents play sports with your children and develop common interests to engage them.
- 4. As adults go for regular walks, play sports, go to gym, participate in community sports, keep engaged with your friends and relatives and develop common interests and implement changes in your lifestyle. Remember group work is sustainable and provides you enjoyment and reinforcement from each other. It also helps you to think positively and change your mindset.
- 5. Develop regular habits of engaging into outdoor activities, such as camping, bike riding, hiking etc.
- 6. Establish a personalized plan in consultation with your doctor to tackle overweight/obesity. This can also provide you with the opportunity to assess your overall health and any underlying problems that can be picked early and managed early. Prevention is better than cure!
- 7. Formulate a dietary plan. My advice to you is to have 5 small healthy meals a day. Start your breakfast at 7 am, have some fruit at 10:30 am, small lunch at 1 pm, another piece of fruit at 4 pm and dinner at 6:30 pm. Details plan can be worked out with your dietitian or your doctor to suit your needs. Please remember to consume lot of fruits, salads, vegetables and foods that are slowly digested (low GI). Avoid having takeaways, processed foods, high calorie foods such as some of cereals, drinks such as soft drinks, cordials, juices etc. Avoid excess alcohol consumption and drink plenty of water. The foods you should also be avoiding are cakes, biscuits, ice creams, chocolates, sweets etc. This is only a general guideline

With 5 meals a day, portion control is crucial. Only consume small amount at a time and in a timely fashion to keep your body's metabolism going!

8. There are other extreme measures such as medications and surgical options to manage obesity which is outside the scope of this article.





Do not leave until late and think that it can be fixed later. Prevention is better than cure and achieving health goal is much harder if not intervened early. Intervention starts from pregnancy and continues in our life.

- Socioeconomic status people with lower level of education and lower incomes are more likely to be overweight and obese
- Genetic factors passed onto you from your parents and grandparents.
- Defect in metabolism and other environmental factors.

### Complications or health problems associated with obesity:

As I have mentioned before obesity is the commonest and greatest cause of chronic diseases or health problems. At the same token it is preventable. With avoidance of overweight/obesity lot of health problems can be avoidable if we understand its implications and what to do about it?

Let me list some of the very important chronic health problems obesity can bring.

- 1. Cardiovascular problems related to heart and blood channels such as angina, heart attack, high blood pressure and stroke.
- 2. Musculoskeletal osteo-arthritis, chronic lower back pain, soft tissues, tendon and muscle pain, foot pain and problems and problems with mobility such as balance and falls.
- 3. Endocrine or hormone related problems - diabetes, gout, thyroid problems and polycystic ovaries affecting fertility in women.
- 4. Digestive system related problems fatty liver that can lead to liver failure, gall bladder stone, reflux disease, pancreatitis(inflammation of pancreas - can be life-threatening), increased risk of bowel, gall bladder and pancreatic cancer.
- Kidney failure, kidney stones, kidney cancer, prostatic cancer in men, sexual problems and urinary problems are

- some of the health issues associated with obesity.
- Respiratory problems such as aggravation of asthma, sleep apnea (risk factor for heart attack and stroke), and other respiratory problems.
- 7. Reproductive/fertility related such as period problems, increased pregnancy losses, fertility problems, cancer of the breast, uterus and endometrium are also high with obesity.
- 8. More importantly obesity can cause stress, depression, lack of self-esteem, poor quality of life and mobility.

### What can be done to prevent obesity? Or perhaps manage and reduce obesity?

Crucial factor about management of obesity is the understanding and change in our mindset as to why we have to do it and in what way it affects us? From previous explanation, it is obvious that obesity can cause profound health problems. Therefore, it is in our interest to do something about it if we want to enjoy our life. After all we are only born once!

### Conclusion - things to remember

- Overweight and obesity are preventable conditions.
- It has profound impact in your health and wellbeing.
- Early intervention can be greatly beneficial to avoid complications
- This remains the greatest risk factor for chronic medical or health problems and remains the most important challenge for our society.
- Overweight/obesity has enormous economic burden in our society and is rising exponentially.



## 39 Nepalese receive scholarship to Australia for 2014 the links between the people of our countries, as well as give them the s

ducation Secretary Narayan Gopal Malego and Australia's Ambassador to Nepal, Glenn White presented Australia Awards to Nepali recipients amid a function that the Australian Embassy had organised in Kathmandu recently.

Thirty-nine Nepalis have received Australia Awards Scholarships to pursue postgraduate studies in Australia in 2014. The recipients also attended a daylong orientation on studying and living in Australia. Within the group, 16 are women and 19 are government employees. Australia is one of the largest providers of scholarships in Nepal.

These scholars will pursue studies in Australia's priority sectors in Nepal, which include health, education, governance, livelihoods, water and sanitation and forestry. Some awardees will study courses in public



health, public policy, special radical surgical techniques, occupational therapy, development economics and development studies.

Four of the recipients have received Australia Awards on water management which falls under Australia's regional scholarships for Nepal, India, Bhutan and Bangladesh. Speaking at the programme, Ambassador White said, "I am very pleased with the calibre of awardees this year." He said Australia can provide this opportunity to 39 Nepalis to experience Australia's excellent universities."

He said that Australia has seven universities ranked in the global top 100, which will provide another opportunity to strengthen the links between the people of our two countries, as well as give them the skills and knowledge to achieve great things for Nepal. The Australian government currently invests over Rs 21.4 billion annually in scholarships through the Australia Awards globally to provide opportunities to the best and brightest in partner countries to study in Australia.

In a press statement, the Australian Embassy said Australia Awards are prestigious international scholarships and fellowships funded by the Australian Government which not only develop skills and knowledge but also build enduring people-to-people links between Australia, regional neighbours and the broader international community.

It said the scholarships aim to contribute to the long-term objectives of developing countries to promote growth and stability. It further said the scholarships equip recipients with the skills and knowledge to drive change and contribute to the economic and social development of their own countries. According to the statement, around 440 Nepalis have been supported through the awards.

Many of these scholars are now members of the Association of Nepali Alumni from Australia and hold important positions in the government, private sector and civil society.

## Asia outperforming Australia in teenage education

major global ranking released recently, which evaluated knowledge and skills of 15-year-olds, has showed Australian teenagers reading and maths skills have fallen so far in a decade that nearly half lack basic maths skills and a third are practically illiterate.

Asian countries like China, Japan and Korea have outperformed the rest of the world in the Organisation for Economic Co-operation andDevelopment (OECD)'s latest PISA survey in which over half a million 15-year-olds in 65 countries took tests in the three subjects.

The dumbing down of a generation of Australian teenagers is exposed in the latest global report card on 15-year-olds'



academic performance. Migrant children trumped Australian-born kids while girls dragged down the national performance in maths, the 2012 Programme for International Student Assessment (PISA) report, revealed the survey. Australia's maths performance dropped the equivalent of half a year of schooling between 2003 and 2012. And rowdy classrooms and bullying are more common in Australia than overseas, the report says.

The results have come as a shocker for the UK with British students faring poorest in mathematics — coming 26th in the league table. In English reading, they ranked 23rd and 18 in science. Shanghai (China) and Singapore were top in mathematics. Students

in Shanghai scored the equivalent of nearly three years of schooling above most OECD

## \$14 million for a book



the first book written in what is today the United States of America fetched \$14.2 million in New York recently, becoming the world's most expensive printed book sold at auction. The translation of Biblical psalms "The Bay Psalm Book" was printed by Puritan settlers in Cambridge, Massachusetts in 1640 and sold at a one-lot auction in just minutes by Sotheby's.

Bidding opened at \$6 million and closed swiftly at a hammer price of \$12.5 million, rising to \$14.165 million once the buyer's premium was incorporated.

The book, with its browning pages and gilt edges, was displayed in a glass case behind the auctioneer to a relatively small crowd which attended the less than five-minute auction in person.

The settlers, who came to America to seek religious freedom, had set about making their own preferred translation from the Hebrew original of the Old Testament book after arriving from Europe.

Sotheby's named the buyer as David Rubenstein, the billionaire American financier and philanthropist. He was in Australia and his bid was conducted by telephone.

The world's most expensive manuscript, the handwritten Codex Leicester, 72 pages of largely scientific writings by Leonardo da Vinci, was bought by Bill Gates in 1994 for \$30.8 million.



Portions like these can turn off the readers, though there are nuggets like: May be the restless and wandering souls and spirit of the deceased persons had forced him to come to Nepal once again to get into a 'Divine Trap'.

With a little bit of rewriting, proofreading and repackaging, Chakravuyh can be a far more engaging read than it is now.



## **Prajwal Kafle wins top** physics award from **Sydney University**

Nepali scientist, who was previously involved in a research that showed that the Milky Way (Earth's home galaxy) is on a 'diet' and is a lot slimmer than we previously thought, has been awarded "Postgraduate Excellence in Physics 2013" by NSW-Australia Insititute of Physics for his doctoral thesis

Prajwal Kafle, a PhD candidate at the Sydney Institute for Astronomy (SIFA), School of Physics was presented the award for his PhD thesis titled, "The Light and Dark Side of the Milky Way Galaxy", which was earlier nominated as the best PhD Thesis by The University of Sydney.

This is equivalent (because unlike undergraduate PhD is never marked hence it is ranked qualitatively) to the university gold

"The formation and evolution of galaxies is one of the major puzzles of astrophysics. To unravel the mysteries our approach is anchored to observations of our own Milky Way galaxy as it provides a link to the distant universe. Our galaxy is surrounded by a tenuous envelope of stars called the stellar halo," wrote Kafle explaining his Thesis. "These stars are found to have velocities that cannot be solely accounted for by the luminous component of our galaxy, indicating the presence of the mysterious 'dark matter'. This dark matter dominates the evolution of structure in the Universe. So far there is no direct detection of dark matter, however, its nature such as shape and mass can be inferred from it gravitational influence on the stars motion.

He further said a variety of methods, each with its own assumptions and inherent



limitations, has been used to determine the

"An accurate measurement of the mass has important repercussions in many sectors in Galactic Astrophysics. Kafle's research describes how he measured the Milky Way's total mass to be about a trillion times the mass of the Sun," Kafle said.

Kafle had earlier led a team of University of Sydney astronomers to show that the Milky Way is a lot slimmer than we previously thought and that like all galaxies, the mass of The Milky Way Galaxy dominated by an immense "dark halo" that can only be studied through detecting its huge gravitational pull, and our location, deep in the disk of the

## Australia researchers make leukaemia treatment breakthrough

ustralian scientists say they have breakthrough in ground-breaking technique for treating aggressive forms of leukaemia.

Researchers at Melbourne-based Peter MacCallum Cancer Centre have found a double-barrelled approach which would hopefully lead to long-term survival of those suffering from the blood cancer, according to a media report. A mutant enzyme called JAK2 drives and feeds a virulent form of the disease that has proved resistant to therapy.

These are things that are very difficult to treat because of how quickly they spread but, in addition, they cannot be treated by the common chemotherapy, however, the dual-pronged attack has already proved



successful in completely curing this form of leukaemia in mice.

Researchers hope the treatment will be available to patients within a year.

## Triple Zero App Launched in Victoria

he Victorian Government has launched a new mobile app 'Emergency+ that will help people calling triple zero (000) identify their exact location when calling from mobile phones. The app is a federal initiative that connects users to triple zero and utilises smartphone GPS technology to give the user their exact location by longitude and latitude.

Launching the new app Minister for Police and Emergency Services Kim Wells said "This is an important innovation that will enable people in trouble or difficulty to provide their precise location information to triple zero operators," "People calling triple zero may be in unfamiliar surroundings with only limited understanding of their location details. They can also be under great stress as a result of their emergency, making it difficult for triple zero operators to get the information they need to dispatch emergency services.

"The location of a caller is the first most important piece of information the triple zero operator needs. This app has the potential to gather that information quickly and

It was developed by the national Triple Zero Awareness Working Group that




includes emergency services agencies from the Commonwealth, states and territories. According to Victoria's triple zero operator ESTA, 56 per cent of incoming calls to triple zero were made from mobile phones.

"This is a great innovation but one that we hope doesn't need to be utilised often,' Mr Wells said.

The app includes a button for triple zero as well as one that takes users to the dedicated SES line 132 500. These numbers are common throughout Australia.

There is a third button on the app for the Police Assistance Line (131 444) which is for non-emergency matters. Victoria Police do not yet provide this service but a project is underway to investigate the best way to connect Victorians to Police for non-emergency matters.

## Unmet aspirations: on thirty years of SAARC

outh Asians celebrated the 29th Charter Day of the South Asian Association for Regional Cooperation (SAARC).

As SAARC approaches its 30th year, it is perhaps the right time to look back at what it has done in its three decades of existence. This is important to evaluate what it can (or cannot) do for the people of this region in the next decade and beyond.

"Desirous of promoting peace, stability, amity and progress in the region" the seven countries of South Asia, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka came together in Dhaka and signed the Charter to establish SAARC on December 8, 1985. In 2007, Afghanistan became its eighth

From a modest start, cooperation has multiplied and diversified to encompass areas as diverse as poverty alleviation, trade, finance, culture, environment, social develare created and meet as required.

The Memorandum of Understanding on the Nepal-based Secretariat says "The role of the Secretariat shall be to coordinate and monitor the implementation of SAARC activities and to service the meetings of the Association, and initiate of proposals for regional cooperation, preparation of projects for regional cooperation and identification of sources of funding".

Represented by Buddha, Gandhi, Tagore and Taj Mahal South Asians have had a glorious past. By population it is the largest regional grouping and with reforms in the values base, governance and harmonized national interests, South Asia has the potential to grow fast and catch up with many other peaceful and prosperous regions. But amidst a great past and future potential, South Asia lags far behind in the critical matrix of poverty-prosperity, peace-violence, corruplimited to a forum for exchanging diplomatic niceties and dealing with peripheral matters, but unwilling or unable to address the real issues confronting South Asia today, let alone prepare the region for a new age.

And prepare South Asians must as they stand at a crossroad of time and space, poised for peaceful and positive transformation but also with many inherent risks.

These challenges can be resolved only within a new paradigm that harmonizes national, cultural, communal, institutional and individual interests with regional and global frameworks. South Asians must embark on building new highways of hope and healing connecting all nations and peoples. For this some old walls have to be demolished, and new buildings or bridges built. Such new political-economic-security community building begins by restructuring the state and society through upward evolution (harmonization of policies within South Asia, Asia and globally) and downward devolution (sub-national to trans-national levels of state-society structures and institutions).

These vertical and horizontal adjustments will strengthen, not weaken the South Asian nation-states by making them more tolerant, inclusive, dynamic and responsive institutions of governance in an increasingly complex world. This new project of politics, economics, society-building and foreign and security policy making starts with a new intra- and inter-state contract where everyone respects the rights of others as well as employ science, technology, natural resources and political power for the happiness of all.

For such a new paradigm, more than anything else, South Asia needs a new mindset, a new consciousness that can generate ideas and build institutions to best cater to the needs and aspirations of all South Asians. With this new thinking South Asia of tomorrow could transcend its limited boundaries while strengthening individual, local, national, regional and global interests.

South Asia has remained stuck in terms of practical interest harmonization in politics, economics, security and many other areas, primarily because there is no normative foundation on the nature of society, state and region. SAARC is the best venue to start the conversation.

But if the hesitation on the part of those responsible for taking the SAARC process forward continues, more and more South Asians may see the logic in the question Dhruva Jaishankar, an Indian scholar, poses in his recent Foreign Policy article "...beyond one rather ineffectual international organization and a handful of sporting events, does 'South Asia' even exist?'

opment, security, science and technology, and tourism. Eight Agreements including one on establishing the South Asian Free Trade Area (SAFTA) and six Conventions have been signed.

The Food Bank and Development Fund is another important new initiative to promote greater regional integration. SAARC Seed Bank, Multilateral Arrangement on Recognition of Conformity Assessment, Rapid Response to Natural Disaster and Implementation of Regional Standards were signed during the 17th SAARC summit in the Maldives

Moreover, the SAARC Social Charter and the Charter of Democracy are steps towards creating a palatable common political and social order. The South Asian University can spur greater intellectual interaction and innovative thinking essential for greater regional consciousness, common identity and cooperation.

The Summit of the Heads of State or Governments is the apex SAARC organ. In 29 years, 17 Summits have been held. The Council of Ministers is the principal policy making body which meets twice between the summits. The Standing Committee is made up of the Foreign Secretaries under which a number of Technical Committees and Action Committees

tion-governance and state capability-fragility.

The regional trading regime is weak. Connectivity and movement in the region is cumbersome: the Berlin wall has fallen but in South Asia old walls remain and new ones are being built. As one of the nuclear locked regions, South Asian security environment remains fragile. Identity and consciousness based on minimum values-consensus is a distant agenda. In the international arena. South Asia presents a fractured picture.

One former Secretary General of the organization admits "SAARC has hardly progressed beyond signs and symbols" and "the people of South Asia are yet to feel the tangible benefits of cooperation."

Vulnerable to internal politics, bilateral conflicts and extra-regional influences, the founders were careful to protect SAARC in its initial years. SAARC has survived its infancy and adolescence and now entered a stage of maturity. Is it perhaps time to reflect on its transformation, enabling it to take on more significant issues that impede substantive regional cooperation?

Both critics and well wishers believe that without serious reflection and significant transformation SAARC runs the risk of being

## Nepal returned a gift of Archaeologists confirm

n elegant Beaux-Arts ballroom in San Francisco's financial district in a recent night, Laurene Powell Jobs received a computer with an unusually rich history. Around 1980, Ms. Powell Jobs's husband, Steven P. Jobs, donated the computer to a non-profit organization, the Seva Foundation of Nepal to help the group manage data from its efforts to restore sight in the developing world.

The non-profit was now giving the computer - an Apple II that spent the last 33 years in Kathmandu, Nepal, most of it packed away in a hospital basement there - back to Ms. Powell Jobs and her children from her marriage to Mr. Jobs. The Apple II would be little more than an artefact in the history of a non-profit organisation if it was not also a rare symbol of the charity of Mr. Jobs, a man celebrated for his vision

and leadership in the technology industry but who was routinely criticized before his death for his lack of giving. Some other billionaire technology innovators have given away huge chunks of their wealth - most notably Mr. Jobs's long-time rival, Bill Gates. But Mr. Jobs shied away from philanthropy, at least of the public variety. Although his wife has long been an active benefactor of various causes, Mr. Jobs was portrayed as somewhat disdainful of philanthropic endeavours by his authorized biographer, Walter Isaacson

Ms. Powell Jobs accepted the computer with her son, Reed, at a ceremony commemorating the organization's 35th anniversary. Seva says it has helped restore sight to 3.5 million people in Bangladesh, Cambodia, Nepal, Tibet, India and other countries since it was founded.

## Steve Jobs back to his wife early date of Buddha's life

rchaeologists working in Nepal have uncovered evidence of a structure at the birthplace of the Buddha dating back to the sixth century B.C. and this is the first archaeological material linking the life of the Buddha to a specific century.

Excavations within the Sacred Garden of Lumbini, a UNESCO World Heritage site identified as the Buddha's birthplace, led to the remains of a previously unknown timber structure under a series of brick

Laid out on the same design as those above it, the timber structure contains an open space in the centre that links to the nativity story of the Buddha himself.

Buddhist tradition records that Oueen Maya Devi, the Buddha's mother, gave birth to him while holding on to the branch of a tree in the Lumbini Garden, midway between the kingdoms of her husband and

Brick temples built later also were arranged around the central space, which was unroofed.



Geo-archaeological research has confirmed the presence of ancient tree roots within the temple's central void.

Lumbini is one of the key sites associated with the life of the Buddha. The others include Bodh Gaya in India where he attained enlightenment, and Sarnath, also in India where he first preached.

Lost and overgrown in the jungles of Nepal in the medieval period, ancient Lumbini was rediscovered in 1896 and identified as the birthplace of the Buddha on account of a third century B.C. sandstone pillar.

### Indian, Nepalese hospitals tie up for cancer treatment



leading Nepalese hospital has tied up with an Indian super speciality hospital to offer better treatment to cancer patients here in a first-of-its kind cooperation between the two countries, it was announced Monday.

Baidva and Banskota (B&B) Hospital of Nepal has signed an agreement with India's BL Kapoor (BLK) Super Speciality Hospital to launch the B&B-BLK Cancer Centre here. Announcing this, officials of the two hospitals said super specialists from the BLK Cancer Centre based in Delhi shall provide their expertise to the Kathmandu centre and will also train Nepalese doctors and nurses.

The BLK hospital is among the oldest and most respected Indian hospitals with a

global outreach. The hospital has a modern healthcare facility with 700-bed capacity.

The hospital has Asia's first CyberKnife VSI - a full body robotic radio surgery system for painless and precise treatment of hitherto inoperable tumours. The B&B-BLK Cancer Centre will provide both medical and surgical treatment to patients, including outpatient department consultation, chemotherapy, treatment planning and surgical procedures depending upon patient's

The centre will begin its operations last month with the head of oncology department and senior consultants of BLK visiting the wards.

### Leonardo DiCaprio donates \$3 million to save Nepal's tigers

ctor Leonardo DiCaprio through his foundation has donated USD 3 million to World Wildlife Fund to support Nepal's attempt to protect and nurture tigers in the country.

"Time is running out for the world's remaining 3,200 tigers, largely the result of habitat destruction and escalating illegal poaching," WWF board member DiCaprio said in a statement.

"WWF, the government of Nepal and local communities are on the front lines of this battle, and I am hopeful this grant will help them exceed the goal of doubling the number of these noble creatures in the wild," he further said.

The donation will be used to help







achieve the goal to double the number of wild tigers by 2022, the next Chinese year of the tiger. With the money, park rangers at the 9,000-square-mile Terai Arc Landscape of Nepal will be able to "strengthen anti-poaching patrols, protect core areas for tiger breeding, restore critical corridors for their dispersal and expansion and continuously monitor tiger populations."

"Protecting a top predator like the tiger helps keep forests and grasslands intact, and ensures that other species like rhinos and elephants can thrive," said Justin Winters, executive director of the Leonardo DiCaprio Foundation, in a statement.


In May, DiCaprio raised USD 38.8 million through donations and an art auction at Christie's in New York.

## Towards ECONOMY-FRIENDLY ATMOSPHERE

ill Nepali economy re-witness a friendly atmosphere for Gari Khana Deu (allow us to work and earn living)? Will investors feel safe, like in early 1990s, to pour in capital in productive enterprises in the country? Will the trend of stoppage (Banda) give way to a culture of no disruption to economic activities in 2014?

Such questions are being raised today in Nepal as the newly elected Constituent Assembly heads for preparatory works to begin its parliamentary business towards mid-December. Wage-earners, labourers, investors and all those who want to work and earn living are looking forward to the economic policy that the new government will adopt as it assumes office in the near future.

Office bearers of top bodies of business/ industrial community such as Federation of Nepali Chambers of Commerce and Industries (FNCCI), Confederation of Nepali Industries (CNI) and Nepal Chambers of Commerce have publicly voiced, in an optimistic note, for economy -friendly atmosphere under fresh leadership of new CA.

Nepali economy has been a victim of political uncertainty and series of obstacles linked with it for the past decade and a half. The conflict time chaos and the subsequent post-conflict volatility derailed the economy in a shocking manner. As a result the country is witnessing serious problems of poverty, unemployment, power-shortage and un-productivity.


### Rosy schemes

Political parties this time included economic plans and programmes in their manifestoes in an unprecedented way. The schemes mentioned in their commitment-paper look very ambitious and populist. They appear to have been drafted just to impress voters. Leaders, however, claim that they are achievable.

The Nepali Congress emphasized increase in employment as the main economic goal. The CPN UML chose the village oriented economy as the most important target. The UCPN-M stressed the need to end load -shedding in three years. Major parties aimed at economic development, village development, employment creation, end of power shortage, modernization of agriculture, unemployment benefit, and local development.

Various political parties have expressed commitment, in words, not to disturb the economy through strikes. Over the past few years and until recently, political parties utilized the instrument of strike to protest against the government and to press for their grievances. The serious issue of loss - about Rs. 2 billion per day - caused by strike remains un-responded by those who organize strikes. Entrepreneurs have renewed their call that organizations which call strike should compensate the loss caused by the strike.

The new Constituent Assembly should first work out a scheme of political solution which holds the key to prepare atmosphere



for economic agenda. Entrepreneurs emphasize the need to pursue liberal economic policy which backs investment- friendly

#### Backdrop

Nepali economy today aims at transforming the country into a developing country by 2022 A.D. (2080 B.S.) from Least Developed Country. In an effort towards achieving the target, the on-going Three Year Plan (2013-16) aims at economic growth rate of 6 %. The growth rate in the fiscal 2012-13 stood at 3.5 % only.

The vulnerable, poor economic situation is something that most government documents, donors' projects and private sector investors refer to very often. Important documents such as the government budget for the fiscal year 2012-13, the ongoing Three Year Plan (TYP 2010-11-2012-13), and the latest government scheme - Immediate Governance and Economic Action Plan-2012 have also mentioned it as a backdrop of the economy. Economic discourse is routinely prefaced by the poor economic status of the country.

The private sector particularly the business sector has been playing a great role in the economy over the past 22 years. Various legislations introduced after 1990-free market provisions have secured the interest of the business sector, say officials of Nepal Chamber of Commerce and Industries. But they are critical of the government's trust in the private sector.

#### Latest scenario

The country witnessed its first full annual budget in time, after two years, on July 15, 2013 raising hope for stability in economic situation. The way Foreign Direct Investment

Economists, however, doubt about it pointing at the continuing political instability and the prevailing low growth rate of 3.5 % in the fiscal 2012-13.

The overall anatomy of the country's economy could be viewed through the budget for the fiscal 2013-14. The country is at present pursuing an annual budget of Rs.517.24 billion. It seeks to attain economic growth rate of 5.5 %. The government plans to tame inflation at 8 %. It plans to raise Rs. 43.7 billion foreign loan and Rs. 44 billion from internal loans.

Import plays a dominant role (87.6 %) in foreign trade of Nepal while export-role is limited to 12.4 %. Import went up by 22.1 % and cost the country Rs. 360.56 billion in the fiscal 2012-13. Nepal - export could not


